SUBJECT:	Service Order with Spectrum (formerly Time Warner) to upgrade the Dedicated Internet Access and Ethernet Private Line Service (Transport Line) between City Hall and Public Works/City Yard

BACKGROUND

Since September 15, 2008 the City has employed Time Warner to provide City Hall with Dedicated Internet Access and Ethernet Private Line Services. The Dedicated Internet Access is to provide all computers, servers and other devices general access to the internet, whereas the Ethernet Private Line Services is a point to point transport line from City Hall to the Public Works yard to connect telephones and computers to City Hall servers. The current contract entered into on October 20, 2014 with Spectrum (formerly Time Warner) will expire on October 19, 2019, but that agreement allowed for continual month-to-month service until a new agreement could be reached.

The original service levels were deemed satisfactory and have served the City well, however since then, bandwidth has significantly decreased in cost considerably and the needs of the City for increased connectivity have grown. As a result, there was a desire to evaluate current service levels, the needs of the City to function, and a concerted effort to decrease service expenses.

STAFF REVIEW

Staff has determined that the current service levels for Dedicated Internet Access have been sufficient for the needs and operations of the City and any upgrade in service level would be a significant improvement, especially the Ethernet Private Line service. As a result, staff solicited and reviewed offers from three different service providers (Time Warner, AT&T, and the proposed South Bay SmartNet Fiber Network) to upgrade current service levels. A summary of the three proposals is provided in the chart below:

After consideration of every package and possible combination, even a "mix and match" with different service providers, Spectrum provided the ideal package with an increase in services and a significant decrease in cost.

The new service would provide a more than 2x increase in speed for Dedicated Internet Access, for a 44% reduction in monthly cost. As well as, providing a 5x increase in speed for Ethernet Private Line Service for a 20% reduction in monthly cost.

Acceptance of the lowest cost proposal would do the following: 1) create annual savings of \$6,492 in the internet and transport service fees; and 2) significantly increase bandwidth for City Hall and the Public Works Yard. At this time, staff recommends the acceptance of the Spectrum proposal due to it meeting the City's functional needs as well as its cost savings.

LEGAL REVIEW

The City Attorney has reviewed the service order and has approved it as to form.

FISCAL IMPACT

Dedicated Internet Access and Ethernet Private Line Services have been budgeted for fiscal year 2019-2020 in the following account:

100-180-530.100 – Contract Services (Information Systems)

Approval of the proposal would mean an approximate savings of \$4,400 for fiscal year 2019-2020.

RECOMMENDATION

Staff recommends that the City Council approve the service order with Spectrum for upgraded bandwidth on Dedicated Internet Access and Ethernet Private Line Service (Transport Line) between City Hall and Public Works/City Yard, for a five year term for an amount not to exceed \$17,700.00 annually.

BACKGROUND

In order to provide an update on the City of Lawndale's financial position as of June 30, 2019, a Quarterly Budget Update has been prepared. Since this update is at fiscal year-end, all funds were included in the review with attention focusing on General Fund revenue and expenditures, any funds with negative balances at year-end and significant fluctuations between budgeted appropriations and actual expenditures.

STAFF REVIEW

At fiscal year end, the General Fund had a positive budget variance of \$907,218; \$568,787 related to actual revenue exceeding anticipated revenue and \$338,421 of unspent budgeted appropriations. Building permit and plan check fees, property tax and sales tax attributed to actual revenue exceeding the budget. The net unexpended appropriations were attributed to \$874,528 capital project funding continued into fiscal year 2019-20 and savings in contract police services and municipal services personnel cost. These savings were offset by \$540,211 costs exceeding the budget for Public Works and Street Maintenance personnel costs and City Attorney and Planning/Building Administration contract costs.

Five funds had negative balances at fiscal year-end; cost for two of the funds will be submitted for reimbursement in fiscal year 2019-20; three of the funds require \$186,647 of funding from the General Fund to resolve the negative balances and close the funds. Of the capital project funding available at fiscal year-end, \$6,316,825 was continued into fiscal year 2019-20 for ongoing projects.

OVERVIEW

This quarterly report represents the City's unaudited year-end revenues and expenditures results through June 30, 2019. It highlights the financial results of the General Fund and also includes the results of all other funds maintained by the City.

GENERAL FUND

The General Fund supports the day-to-day activities of the City, which includes general government, public safety, municipal services, planning and community development, recreation and community services and public works. The General fund activities are primarily supported from sales and use, motor vehicle inlieu, utility users and property taxes.

General Fund Financial Condition: Fiscal year 2018-19 has closed with accruals being booked for the year and appropriations being continued for multiple year projects. Adjustments can still be made as the result of the year-end audit scheduled to be completed by December 31, 2019. Overall, the General Fund had a positive budget variance of \$907,218; \$568,797 related to actual revenues exceeding anticipated revenue for the year and \$338,421 related to actual expenditures being less than appropriations budgeted.

Revenue. General Fund, which was 57% of the City's total actual revenue, was \$2,872,209, 21%, higher than fiscal year end June 30, 2018. The significant year-to-year increases were attributed to the sale of land, passage of Measure L (new ³/₄ cent district transaction tax), increase in sales tax and an increase in building permit fees which attributed to \$1,407,607, \$533,490, \$334,287 and \$236,392 of the respective increase. In addition, fiscal year 2018-19 ended with actual revenue being \$568,797 higher than the amended budget as summarized below.

- Charges for Services: Revenue includes planning, building and community center fees which increased 36.8%, \$404,628, over fiscal year 2017-18. The most significant increases were building permit fees and plan check fees yielding an annual increase of 62.7% (\$236,392) and 49.5% (\$81,353), respectively. Compared to the amended budget, actual revenue was \$184,563 and \$94,309 higher than anticipated.
- *Property Taxes:* Property taxes increased \$217,868, 16.3%, from \$1,338,432 for fiscal year 2017-2018 to \$1,556,301 for fiscal year 2018-19. The increase was attributed primarily to taxes on the sale of City Owned property \$134,304, an increase in pass-through taxes from the Redevelopment Successor Agency of \$39,530 and an overall 5.6% increase in property assessed values in the City.
- Sales and Use Taxes: Sales tax revenue was \$3,171,572 for fiscal year 2018-19 compared to \$2,836,285 in fiscal year 2017-18. The \$335,287, 11.8% increase was partially attributed to system changes at the California Department of Tax and Fee Administration which caused a delay of processing and distributing sales tax. Some of the taxes for 2017-18 were receipted and distributed in 2018-19 causing an increase. In addition, sales increases in the auto and transportation industry and increased gasoline prices attributed to the overall sales tax increase for the year.

Public Works Capital Projects

Of the unexpended appropriations at June 30, 2019, \$199,684 and \$201,284 (\$400,968 total) was attributed to building improvements and street improvements, respectively. Specifically, \$200,000 of general fund reserves was budgeted in fiscal year 2017-18 to replace the roof at City Hall. The funding was continued to fiscal year 2018-19 and still unexpended as of June 30, 2019 (less a charge of \$316 posted against the account). The intent is to develop a project design and specifications to solicit bids and complete the project in fiscal year 2019-20. As for the \$201,284, this money was approved by City Council on June 17, 2019 to be transferred, as local matching funds, for annual street improvement projects. The money has been continued into fiscal year 2019-20 for the Grevillea Avenue Improvement, Road Maintenance and Rehab Alleys FY2017-18 and Road Maintenance and Rehab Streets FY 2018-19 projects.

Sheriff Services

A budget savings of \$386,981 was realized on the public safety contract with the County of Los Angles due billing rates being less than the agreement amount and a four month vacancy of the motor deputy during the fiscal year.

Municipal Services Salary Savings

The Municipal Services Department had salary savings of \$86,579 at fiscal year-end attributed to the vacancy of the Director (July – September), the Emergency Services Coordinator (May – June) and one part-time Municipal Services Officer being budgeted but not filled.

Public Works Personnel Cost Overruns

Public Works Administration consists of three full-time positions and costs are recovered primarily from Proposition C – Local Transit and grant programs. Only a small fraction (.03 FTE) of salary and benefit costs was budgeted to be recovered from the General Fund. However, actual administrative costs charged to Proposition C and Measure R exceeded the twenty percent administrative cost recovery allowed against these programs, therefore, the excess costs were reallocated to the General Fund totaling \$226,376. In addition, \$63,676 of the administrative costs charged to the expired SAFETEA-LU grant was charged back to the general fund in 2018-19 and a \$21,538 prior period adjustment against fund balance is required for past year administrative costs charged against the same grant program.

City Attorney

Actual legal expenses exceeded the budget for the fiscal year by \$89,292, which is consistent with prior years. This is attributed to the City's need to use the Attorney's Office for legal issues such as Code Enforcement. Costs have consistently exceeded the budget without the budget being adjusted or services reduced to be in line with the established appropriations. Below is a summary of total legal expenses (all funds) compared to total budget for the previous five fiscal years. Fiscal years 2014-15 is the only year actual expenses were within the budget.

Planning/ Building Administration

The most significant factor attributing to the net \$95,296 operational overrun in the Community Development department was the Building Safety Services expense, which was \$120,280 over the \$266,305 budget. Building Safety Services are contract building inspection services provided by the County of Los Angeles Department of Public Works and are provided at a cost reimbursement basis. A corresponding unbudgeted increase (\$278,872 in building permit and plan check fees) is seen in General Fund revenue under the category of Charges for Services. This appropriation overrun was offset by \$24,984 of various savings in other operational areas of the department.

Street Maintenance

Personnel costs for Street Maintenance staff are fully allocated outside the General Fund in the budget with 82% being recovered from Gas Tax revenue. However, a \$93,941 adjustment was booked at fiscal yearend for costs that could not be recovered from allocated funds 201 and 239. Specifically, \$86,543 from the Gas Tax Fund, Fund 201 and \$7,398 from SAFTEA-LU Fund 239, were charged back to the General Fund. Gas Taxes did not support the allocated personnel costs and the SAFETEA-LU grant expired during the year, therefore, no reimbursement could be obtained for indirect costs charged to the program. See comments under Fund 201 and Fund 239 under the *Citywide Overview – Negative Fund Balances* section below.

Fund 201 - Gas Tax Fund

The State Controller apportions the Highway User Tax (commonly referred to as the gas tax) per *Streets* and *Highways Code sections 2100 through 2127* to Cities and Counties on a monthly basis. The apportionment is based on population, vehicle registration, tax on gasoline sold and tangible property assessed. All distributions received by Lawndale have the same restricted use for "any street or road purpose". The fiscal year 2018-19 budget for the Gas Tax fund was prepared with a deficit of \$117,797 (budgeted appropriations of \$965,080 exceeded the budgeted revenue of \$847,283). As a result, the fiscal year ended with a realized shortfall of \$86,543 (\$782,139 expenditures - \$687,480 revenue). Actual expenditures included Public Works Administration and Street Maintenance personnel costs of \$418,266 and operational costs of \$363,872 for street sweeping, traffic signal maintenance and electricity. Funding from the General Fund is needed to make the fund whole. In addition, Finance will review all funds to ensure appropriations do not exceed anticipated revenue plus any available unexpended funds from prior fiscal years.



Fund 239 – Safe, Accountable, Flexible, Efficient Transportation Equity Act – A Legacy for Users (SAFTEA-LU)

SAFETEA-LU funds highways, highway safety, and public transportation through the US Department of Transportation. The program expired on September 30, 2009; however, multiple extensions were offered to utilize the funds. Lawndale received the grant funding for the Inglewood Avenue Corridor Widening project (Phases I, II and III). The current extension expired on January 1, 2018; however, personnel costs continued to be charged against the fund. These costs were unallowable since the grant had expired. An adjustment for fiscal year 2018-19 expenditures of \$71,074.30 has already been charged back to the General Fund; however, prior year expenditures of \$21,538.13, which are not allowable for reimbursement due to the expired grant will also need to be reimbursed by the General Fund.

Fund 240 - Proposition C25 Grant

Proposition C25 grant funding is dedicated to the Inglewood Avenue Corridor Widening Project. Funding lapsed in February 2019; however, the Interim Public Works Director recently received approval extending the grant period through February 2020. The estimated project completion is November 30, 2019, at which time reimbursement for all outstanding project costs, including the fiscal year end negative fund balance of <\$303,817>, will be requested.

Fund 243 – Metro Surface Transportation Program (STP)

The Metro STP fund accounts for various fiscal year 2017-18 street projects. Projects have been completed and audited by the Los Angeles County Metropolitan Transportation Authority (LACMTA). The <\$94,794.55> negative balance at fiscal year-end represents project overruns which require reimbursement from the General Fund.

Fund 265 - Metro Federal Surface Transportation Program - Local (STP-L) Exchange 2014

On October 23, 2014, Lawndale entered into an agreement exchanging \$490,242 of STP-L funds for \$480,437 (\$490,242 - \$9,805 processing & administrative fee) of Los Angeles County Metropolitan Transportation Authority (LACMTA) funds. The motivating factors for the exchange by Lawndale was increased flexibility in the spending requirements and additional time period to expend the funds. The accounting for the original STP-L funding was established in Fund 265, where \$77,930.75 of street repair costs were captured in fiscal years 2015-16. During the 2017-18 audit, it was determined that the exchange proceeds should have been accounted for in Fund 243, where project costs were captured. A year-end adjustment was made to transfer the proceeds to Fund 243; however the expenditures offset by \$8,670.84 of interest earnings remained in Fund 265, resulting in a negative fund balance of \$69,259.91. There is no funding source to reimburse this negative fund, therefore, general fund reserves are requested to clear the fund so it may be closed.

Fund 275 - Measure R Grant Traffic Signal

The \$55,585 expenditures will be included in November 30, 2019 grant reimbursement claim.



In summary, Prop C25 Grant and Measure R Grant Traffic Signal, Funds 240 and 275, respectively, are ongoing grants and the negative fund balances at fiscal year-end will be submitted for reimbursement in 2019-20. The remaining four funds with negative fund balances at fiscal year-end require General Fund support. The following is recommended for Council consideration.

Negative Fund Balances Prior to 2018-19

To resolve negative fund balances prior to 2018-19, the Unrestricted Fund Balance from the General Fund (prior period adjustments) is required to zero out the funds and close. These adjustments do not flow through the current year budget, instead they utilize the existing fund balance. A total of \$186,647.36 from the General Fund is needed as detailed below. With this adjustment, Unrestricted General Fund Balance (Reserves) will be \$15,346,851, and increase of \$592,368, 4%, from the audited balance at July 1, 2018 and 104% of the \$14,753,233 fiscal year 2019-20 amended General Fund appropriation budget. (In addition, a new General Fund \$1.4 million designation was approved by Council on May 6, 2019 for the City General Plan.)

Total expenditures (including cash transfers and non-operating expenses) for all non-General Fund funds was \$10,038,569 for fiscal year 2018-19. In order to compare actual expenditures to budgeted appropriations, three tables were prepared by expenditure classification (personnel, operational and capital expenditures, which actual expenditures were \$1,185,150, \$5,861,327 and \$989,858, for the respective classifications) comparing the amended budget to actual year-end expenditures by fund. Below is a summary of all funds, excluding the General Fund which we analyzed at the beginning of this report. Excluded from these tables was a \$1,998,000 transfer from the Successor Agency Projects Fund, Fund 304, for the sale of land held by the dissolved Lawndale Redevelopment Agency.

For funds outside of the General Fund, the amended Salaries and Benefit costs (personnel costs) for fiscal year 2018-19 was 2,078,197 compared to 1,185,150 actual expense. The 893,047 unexpended budget was primarily the result of the Gas Tax, Prop C – Local Transit Assistance, Prop C25, Measure R and 2009 TABS funds as described below.

Gas Tax Fund, Fund 201

The \$147,757 remaining salary and benefit budget at fiscal year-end was primarily the result of reclassifying the amount spent over the revenue received during the fiscal year. Specifically, \$687,480 Gas Tax revenue was received during the fiscal year and \$782,139 was expended. Therefore, the \$86,543 over expended salary and benefits expenditures were charged back to the General Fund in the summary. See the Gas Tax paragraph under the Citywide Overview – Negative Fund Balances section above.



Prop C - Local Transit Assist, Fund 207

The \$194,734 remaining salary and benefit budget at fiscal year-end was primarily the result of reclassifying \$145,783 of indirect cost to the General Fund. Proposition C – Local Transit Assistance allows a maximum of 20% administrative costs to be charged against the funding source. Total direct costs were \$433,089 of which \$86,618 (20%) was allowed for administrative costs. Actual administrative costs were \$232,400, therefore, \$145,783 could not be recovered from Proposition C, and was charged back to the General Fund for cost recovery.

Proposition C25 Grant, Fund 240

As noted earlier in report, Proposition C25 grant funding (dedicated to the Inglewood Avenue Corridor Widening Project) lapsed in February 2019; therefore, the project was delayed until approval was obtained to extend the grant period. This resulted in the \$87,818 unexpended budget at fiscal year-end.

Measure R Grant Traffic Signal, Fund 275

The \$85,319 remaining salary and benefit budget at fiscal year-end was primarily the result of reclassifying \$80,593 of indirect cost to the General Fund. The Measure R grant allows a maximum of 20% administrative costs to be charged against the funding source. Total direct costs were \$60,123 of which \$12,024 (20%) was allowed for administrative costs. Actual administrative costs were \$92,617, therefore, \$80,593 could not be recovered from Measure R, and was charged back to the General Fund for cost recovery.

2009 TABS, Fund 307

The salaries and benefit budget was based on allocated costs from Public Works Administration (Director of Public Works and Administrative Analyst, 80% and 25% of respectively personnel costs) and Engineering (Associate and Assistant Engineer 60% and 73% of respectively personnel costs). Except for the Administrative Analyst, the other three positions were vacant, either partially or fully, during the fiscal year. Therefore, actual charges were significantly less (\$244,835) than budgeted.

For funds outside of the General Fund, the fiscal year 2018-19 amended budget for Operational costs was \$7,447,262 compared to \$5,861,327 actual expense. The Gas Tax and Successor Agency Debt Service funds significantly attributed to the \$1,585,935 difference as described below.

Gas Tax Fund, Fund 201

Operational cost of \$485,600 was budgeted in the Gas Tax Fund for street sweeping, traffic signal repairs, maintenance, striping and legend work, engineering studies, and curb gutter and side walk repairs. Actual cost was \$363,872 leaving a budget of \$121,728. With the vacancy of Public Works Director (Contract Interim was hired in January 2019), the budgeted appropriations were not expended on curb, gutter, sidewalk, pavement, street striping or street legend work from Gas Tax funding. The street, sidewalk and other repairs performed during the year related to larger projects with specific funding sources.

Successor Agency Debt Service, Fund 305

Although there appears to be a \$1,088,650 debt service payment savings at the end of the fiscal year, this is not the case. \$1,474,185 of debt service payments were posted directly against the outstanding debt liability rather than accounting for the payments as expenses against the budgeted accounts. Since Fund 305 is a fiduciary fund type, which does not require a budget, no accounting correcting entry will be posted. However, for comparison purposes, following are the actual amounts paid and accrued for during the fiscal year 2018-19:

BACKGROUND

On October 7, 2019, the City Council introduced and approved the first reading of Ordinance No. 1164-19 to amend the Lawndale Municipal Code pertaining to residential property report requirements.

ANALYSIS

The City Council introduced and approved the first reading of Ordinance No. 1164-19, with minor revisions to the ordinance to continue inspections to verify that properties meet the off-street parking requirements, and it is recommended that the City Council adopt Ordinance 1164-19. Additionally, Code Enforcement Officers will continue to make note of any violations visible during the Residential Property Report inspection that are visible to them during the inspection, even those violations outside of the garage.

LEGAL REVIEW

The City Attorney's office has reviewed and approved Ordinance No. 1164-19 as to form.

<u>FUNDING</u>

Staff anticipates some cost savings in staff time and resources related to the residential property report process.

RECOMMENDATION

It is recommended that the City Council read by title only, waive further reading, and adopt Ordinance No. 1164-19 to amend the residential property report requirements.

WHEREAS, in 2007 the City Council expanded the scope of the residential resale report to include an inspection of all current and observed Municipal Code violations that are observable from the public right of way and the interior areas of garages and/or accessory buildings such as detached garages, laundry rooms and storage sheds; and

WHEREAS, the City Council desires to amend the scope of the residential resale report to change the requirement that this report is mandatory to a voluntary process.

Said report shall be valid for the purposes of this chapter for a period not to exceed six months from date of issue and is not intended to provide an exhaustive list of all code violations upon the property."

SECTION 2. This ordinance is exempt from the California Environmental Quality Act ("CEQA") under Section 15061(b)(3) of the CEQA Guidelines, which provides that CEQA only applies to projects that have the potential for causing a significant effect on the environment. Where, as here, it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment, the activity is not subject to CEQA.

BACKGROUND

Public/Street Right-of Way

The parkway is the Public/Street Right-of-Way area of the street between the back of curb and the edge of the sidewalk that is typically planted or landscaped. Since the approval of Council Policy No. 102-18, questions have been asked at Council meetings about the implementation and application of the Policy (See Attachment A, Example Parkways City-Wide).

City Council Action

On February 20, 2018, the City Council reviewed and approved Council Policy No. 102-18, "Parkway Design Policy Guidelines" (See Attachment B). The policy was developed in response to inquiries and interest from residents wanting to make improvements to the parkways adjacent to their residential properties. In short, the policy requires 75% of the parkway to be covered with plant materials.

Current Parkway Conditions City-Wide

Many property owners maintain parkways with alternative materials which do not comply with the municipal code (See Attachment C, Parkways in Violation). For example, the Municipal Services Department has numerous cases in which all green-scape has been removed and replaced with rock and bark materials and/or small plants such as cactus. There are also properties that have removed the majority of the green-scape to install large areas of hardscape.

MSD Pending Cases

While the Parkway Policy was being developed and before it was approved, these MSD cases were placed on hold. Residents certainly could have re-installed 100% turf and resolved their individual cases. However, they were allowed to wait to see what the provisions of the Parkway Policy would be before moving forward with compliance.

STAFF REVIEW

City Council Policy No. 102-18 Parkway Design Guidelines

Currently, City Council Policy No. 102-18, "Parkway Design Policy Guidelines" provides for two landscaping options, with walkable and non-walkable plant materials, with a minimum of 75% live

landscape coverage using turf and other walkable plant materials or other groundcover materials described in the Policy. The minimum amount of 75% of live landscape coverage is the core of the Parkway Design Policy. Coverage of live landscaping can be 100% but no less than 75%. The balance of the parkway space, up to 25%, can be a variety of materials, including hardscape. These materials are outlined in the adopted Parkway Policy.

The intent of the guidelines is to provide a consistent and manageable design palate for all parkways in the City's right-of-way and to provide an area for water to percolate into the ground. Maintenance of the parkways, including those adjacent sidewalk, is the responsibility of the abutting property owner in accordance with the City's Municipal Code.

This matter is being returned to City Council because of comments from City Council at prior meetings requesting a review of the policy. As a result, properties with pending MSD cases have been on hold. Whether the City Council elects to maintain the current policy or revise the policy, these property owners will be advised that the City Council has reconsidered the policy, what the policy requires, and that they are to now move forward and comply with the approved guidelines. Residents wanting new permits are to follow the provisions of the Parkway Policy.

Water Efficient Landscaping In Parkways

Water efficient landscaping is governed by the Municipal Code and installation requires plans prepared by a licensed landscaping architect and an irrigation system that properly maintains the drought tolerant plants. The ratio of 75% live landscape coverage still applies to drought tolerant materials.

COMMISSION REVIEW

On October 25, 2017, the current Parkway Guidelines were taken before the Planning Commission for input and public comment before being brought forward for consideration by the City Council.

LEGAL REVIEW

FISCAL IMPACT

Not Applicable

CONCLUSION

The intent of the guidelines is to provide a consistent and manageable design palate for all parkways in the City's rights-of-way. Maintenance of the parkways, including the adjacent sidewalk, is the responsibility of the abutting property owner in accordance with the City's Municipal Code.

Development of the Parkway Guidelines was a concerted effort undertaken by various departments including Community Development, Public Works, and Municipal Services working together for approximately 7 to 8 months to develop the City's Parkway Policy Guidelines. Therefore, staff recommends keeping the adopted policy minimum requiring 75% of live landscaping coverage for the parkways throughout the City, subject to consideration and approval by City Council.

RECOMMENDATION

Staff recommends that the City Council Discuss Council Policy No. 102-18, "Parkway Design Policy Guidelines" and provide direction accordingly to staff.

WHY ARE PARKWAYS IMPORTANT?



The parkway is the strip of land between the street and the walkway. The parkway and walkway together make up the sidewalk, which is part of the public right-of-way. Street trees are planted in the parkway and are the most important plants in the parkway.

Parkways are important to individual property owners and the City as a whole for the following reasons:

- Parkways provide soil volume that street trees need to grow into healthy, mature trees that provide shade, collect stormwater, consume carbon dioxide (CO2) and provide other environmental and health benefits.
- Parkways can collect stormwater and irrigation runoff and return it to the groundwater table.
- Parkways provide a buffer between pedestrians on the walkway and cars in the street.
- Parkways improve the curb appeal of your home, potentially increasing its value.
- Parkways enhance the visual quality of the city.

In Lawndale, the property owner adjacent to the parkway is responsible for maintaining all of the parkway, except the street trees, which are maintained by the City. The parkway trees can only be planted, trimmed, and removed by the City and not by private property owners (Lawndale Municipal Code Chapter 12).

Parkways can be designed in a variety of ways, depending on the individual property owner's design objectives and commitment to maintenance. However, all parkways should require relatively little supplemental water, little mowing and little fertilizing to reduce their carbon footprint. In particular, conventional grass parkways that require high levels of supplemental water and regular mowing and fertilizing should be avoided. See examples of low water use turf in Table 1, page 5.

To reduce water use, carbon emissions, and provide storm and irrigation water infiltration, soil volume for street trees, a buffer between pedestrians and the street, pedestrian access between the street and walkway, visibility of both motorists and pedestrians, erosion/fugitive dust control, and the visual benefits of landscaped parkways, all parkways must be:

- As wide as possible, minimum walkways widths of 4 feet in residential zones and 5 feet in commercial zones.
- At the same elevation as the top of curb and finished surface of walkway within 6 inches of them, for example, granular soil 2 inches below top of curb and walkway elevations and covered with 2 inches of compacted mulch, so the surface elevations of the walkway or curb and adjacent parkway are the same.
- Landscaped parkways must be irrigated in a manner that results in zero overspray onto the walkway or street, e.g., buried in-line drip irrigation system.

The parkway must be constructed in either of two options ONLY:

Walkable Parkway:

• At least 75% landscape coverage using natural turf and/or walkable plant materials, which require minimum mowing and are drought tolerant. Examples can be found in Table 1. Irrigation schedules must be in accordance with local water service provider (Golden State Water).

Non-walkable Parkway:

- At least 75% coverage using live landscape / groundcover material and either 1) slightly swaled; sloping a few inches to the center at not more than a 3:1 slope, to collect storm and irrigation water or 2) groundcover must be native species, drought tolerant (examples can be found in Table 2), and must include a walkable pathway from the curb to the sidewalk which may not exceed 25% of the parkway.
- All unpaved parkway areas must be covered with a permeable natural material, e.g., compacted mulch, or stepping stones that prevent erosion and dust.

Parkway Requirements and Regulations:

- No encroachment permit is required for the installation or maintenance of grass or live drought tolerant natural turf or other allowable materials per these Parkway Guidelines (at or less than six inches in height) in 100% of the parkway.
- A "conditional" encroachment permit is required for the installation or maintenance of: live plant material other than grass or living drought tolerant natural turf (at or less than six inches in height), OR any nonliving materials including, but not limited to, concrete, decomposed granite and/or compacted mulch – which non-living materials are limited to 25% of the parkway area.

To obtain a "conditional" encroachment permit the property owner or tenant must submit a simple sketch with details of the proposed improvements along with the permit application (photos may be included). A licensed contractor may be required to pull the permit and perform work involving the installation of non-living materials.

 Drawings, sketches, plans, or other satisfactory written materials must indicate the types of parkway landscape materials to be used and respective quantities and a description of how and where each type of parkway landscape material will be applied.

Pavers, stepping stones, and/or other hardscape (limited to 25% of parkway) must be properly constructed

and maintained to not pose a tripping hazard.

- Each owner/tenant must promptly make necessary repairs if improvements are uplifted or damaged.
- Parkways must be maintained and kept free of weeds and otherwise comply with Lawndale Municipal Code Chapter 8.24, Property Maintenance and Nuisance Abatement.
- If parkway improvements fall into a state of disrepair and neglect, a conditional permit will be revoked and the property owner/tenant will be required to remove the improvements and re-landscape the parkway. This requirement is a condition of the permit and be enforced by the City.

For parkways adjacent to curbside parking, if the parkway planting is not walkable (see Table 2 for examples of vegetation that are not walkable), a means of access from the curb to the walkway will be required. The requirement will vary according to the adjacent use and street characteristics, for example:

- On heavily trafficked streets (major and minor arterials), an 18 inch wide paved, walkable strip along the back of the curb that is at the same finished elevation as the curb may be required.
- Where there are striped curbside parking spaces, a path across the parkway may be required every two cars between two marked spaces.

WHAT'S YOUR TYPE?

Type 1 Walkable Parkway - Low-Maintenance, Walkable Plants or Turf

If you want a parkway that requires minimal design and maintenance, install walkable vegetation such as natural turf or other grasses/perennials. Table 1 lists examples. Some of these materials only need to be mowed a few times a year to maintain a lawn-like appearance (see Table 1).

Type 2 Non-Walkable Parkway - Low-Growing, Low-Maintenance Ground Cover

If you want a parkway that requires a little more design and the addition of a walkway or stepping stones (limited to 25% of the parkway),and requires more maintenance, low-growing grasses and/or groundcover are permitted. There are many choices; Table 2 lists some of them. Your parkway may be a mix of grasses and ground cover.

NOT PERMITTED:

- Use of hardscape materials other than providing a walkable strip or covering more than 25% of the parkway
- Use of pebbles and rocks material
- Use of plants with thorns or sharp edges.
- Use of structures within the parkway.
- Use of plant materials that exceed 6-inches in height (excluding trees).

Preparing Your Parkway Soil

The most important thing you can do to ensure your parkway's success is to prepare the soil. Soil preparation saves you money in the long run because it reduces the need to replace plants, lowers water use and reduces fertilizer applications.

- Remove all existing turf let it die and dig it out.
- Remove enough soil to create the swale described on page 2 and then remove 2-3 inches more.
- Till the parkway soil to a depth of one foot.
- Amend it with compost.

Watering Your Drought-Tolerant Parkway

Too much water can kill drought-tolerant plants. So don't over-water, especially in clay soil. The best approach is to water only when the soil is dry at a depth of 3 to 4 inches. Contact Golden State Water Company to verify permissible watering schedules. Additional information on outdoor irrigation may also be available through the water company.

BACKGROUND

In 2013, City Council created and implemented the Lawndale Blues and Jazz Festival. This event originated from a discussion in April 2012 pertaining to a Battle of the Bands events that the Parks Recreation and Social Services Commission (PRSSC) was interested in putting on. This idea eventually became the 2013 Blues and Jazz Music Festival. On July 22, 2013, the PRSSC approved \$9,500.00 for the first Lawndale Blues and Jazz Music Festival in 2013. Due to jazz bands being less prominent in the Festivals' line-up, the event was renamed Lawndale Blues Festival in 2018. The word "Jazz" was removed in 2017 as a result of a PRSSC discussion. In 2019 the City held the 7th annual Festival.

At the Council meeting of October 7, 2019, Councilmember Kearney asked that the City Council consider another changing of the name of the annual festival to "Music Festival".
