SUBJECT:	Adoption of Ordinance No. 1172-20 to Include a Definition of the Term "Responsible Party" within the Municipal Code

# BACKGROUND

Existing portions of the Municipal Code reference a "responsible party," but a definition for this term is not provided. In recent criminal prosecutions the judge has suggested that this is an oversight that needs to be corrected. Accordingly, to provide clarity, Ordinance No. 1172-20 would amend Section 1.04.030 of the Municipal Code to define the term "responsible party" as the person or people who a city official believes is causing, performing, or permitting to exist or otherwise maintaining a public nuisance and includes the owner of the real property involved and any tenant, occupant or user thereof, or any other person in real or apparent charge or control of said real property.

# STAFF REVIEW

Several existing sections of the Municipal Code reference the term "responsible party," but the definitions portion of the Municipal Code, found at Section 1.04.030, contains no definition for this term. Specifically, certain sections in Chapter 8.24, Property Maintenance and Nuisance Abatement, contain this term as relating to the party responsible for the abatement of a nuisance. The judge who oversees many of the City's criminal prosecutions has recently opined that this omission creates confusion with respect to determining the exact party or parties to be held accountable for nuisance conditions on a property.

The City Council unanimously approved the introduction and first reading of Ordinance No. 1172-20 on June 1, 2020.

# LEGAL REVIEW

The City Attorney's office has reviewed the attached Ordinance and approves it as to form.

# FISCAL IMPACT

There will be no fiscal impact associated with this Ordinance.

# RECOMMENDATION

## ORDINANCE NO. 1172-20

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA AMENDING SECTION 1.04.030 OF THE LAWNDALE MUNICIPAL CODE TO ADD THE DEFINITION OF "RESPONSIBLE PARTY"

SUMMARY: If adopted, this ordinance will add the definition of "responsible party" for violations of the Lawndale Municipal Code.

WHEREAS, the City Council of the City of Lawndale has adopted definitions as set forth in Section 1.04.030 of the Lawndale Municipal Code ("LMC"); and

WHEREAS, LMC Section 1.04.030 currently does not include a definition for "Responsible Party"; and

WHEREAS, to hold all potential parties who could be held accountable for compliance with the LMC, the City wishes to establish the definition for "Responsible Party," as set forth herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 1.04.030 of the Lawndale Municipal Code is hereby amended to include the definition of "Responsible Party," in the appropriate place, in alphabetical order, to read in its entirety as follows:

"17. "Responsible Party" means the person or people who a city official believes is causing, performing, or permitting to exist or otherwise maintaining a public nuisance and includes the owner of the real property involved and any tenant, occupant or user thereof, or any other person in real or apparent charge or control of said real property."

SECTION 2. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each and every section, subsection, sentence, clause and phrase thereof not declared invalid or unconstitutional without regard to whether any portion of the ordinance would be subsequently declared invalid or unconstitutional.

SECTION 3. The City Clerk shall certify to the passage and adoption of this ordinance, and shall make a minute of the passage and adoption thereof in the records of and the proceedings of the City Council at which the same is passed and adopted. This ordinance shall be in full force and effect thirty (30) days after its final passage and adoption, and within fifteen (15) days after its final passage, the City Clerk shall cause it to be posted and published in a newspaper of general circulation in the manner required by law.

SUBJECT:	Approve the First Amendment to the Contract Service Agreement with Telecom Law Firm

#### BACKGROUND

On September 27, 2018, the US Federal Communications Commission released a Declaratory Ruling and Third Report and FCC Order (FCC 18-133) that alters the manner and timeframe that state and local authorities may take to review small cell wireless facilities (SCWF) and eligible facilities requests (EFR) in the public rights-of-way (PROW). Further, FCC 18-133 defines SCWF and establishes limitations related to service fees that may be charged. Fees are limited to the actual and reasonable cost of providing service. These provisions also apply in a limited manner to facilities placed on private property. The FCC Order also limits the time that cities have to review and process SCWF applications.

The City Council adopted Ordinance No. 1159-19 to add section 12.60 to the Lawndale Municipal Code (LMC) to establish regulations for SCWF in the PROW.

## STAFF REVIEW

Staff prepared Modified Review Procedures for Administrative (SCWF and EFR) and Non-Administrative (Major) SCWF Permit applications for facilities located within the PROW to comply with the limited review windows and requirements specified by FCC 18-133. On June 3, 2019 the City entered into an agreement with Telecom Law Firm (Consultant) to review application packages for completeness and adherence to applicable local, state, and federal regulations.

The Consultant reviews all administrative and major SCWF permit applications for completeness and adherence to applicable local, state and federal regulations. The Consultant charges a flat fee in the amount of \$2,450 which includes review of the initial substantive application package and one (1) resubmittal package. The fee includes a written memorandum for the initial reviewed submittal and the first resubmittal (if necessary). The current agreement is for a total sum of \$24,500 and expires on June 30, 2020.

At this time, a total of ten SCWF applications have been processed by the Consultant. Staff anticipates additional applications to be submitted in the coming months, therefore, an amendment to the agreement is required to increase the contract sum and extend the term. Staff recommends increasing the contract sum by an additional \$24,500 to include the review of an additional ten applications through a new contract term ending June 30, 2021.

# FISCAL IMPACT

A non-refundable flat fee of \$2,450 is charged by the Consultant to the City for each permit application submitted for review. This cost is paid by the permit applicants per the City's fee schedule. Staff is estimating there will be 10 permit applications through the next fiscal year, therefore, the annual program cost to administer and process the SCWF applications is \$24,500 plus staff time. For fiscal year 2019-20, \$14,892 is anticipated to be paid of which \$5,000 was budgeted. Therefore, an appropriation increase to cover the current year costs and the contract amendment costs is being requested for a total of \$34,392 (\$9,892 for the existing original contract plus \$24,500 for the next fiscal year/ contract amendment).

For each permit, an application fee of \$3,320 is collected. No revenue was budgeted in the current fiscal year, of which \$23,240 is estimated and an additional \$33,200 is estimated for contract amendment services. Therefore, a revenue budget amendment is requested for \$56,440 (\$23,240 on the existing contract for FY 2019-20 plus \$33,200 on the contract amendment). The \$870 collected above the \$2,450 consultant's fee is for cost recovery for staff time associated with the permit process.

Staff recommends the following budget adjustment and requests the unexpended appropriations and related revenue at fiscal year-end to be continued into Fiscal Year 2020-21:

## FIRST AMENDMENT TO CONTRACT SERVICES AGREEMENT FOR TELECOMMUNICATIONS FACILITY CONSULTING SERVICES

This FIRST AMENDMENT TO CONTRACT SERVICES AGREEMENT (the "First Amendment") is made and entered into this 15<sup>th</sup> day of June, 2020, by and between the CITY OF LAWNDALE, a municipal corporation (herein "City") and Telecom Law Firm, P.C., a California professional corporation ("Consultant").

#### RECITALS

WHEREAS, City and Consultant entered into that certain Agreement entitled "Contract Services Agreement for Telecommunications Facility Consulting Services" (the "Agreement") on or about June 3, 2019, and

WHEREAS, it is the desire of the City and the Consultant to amend the Agreement as set forth in this First Amendment to extend the term for one additional year.

#### AGREEMENT

NOW, THEREFORE, it is hereby agreed that the Agreement is amended in the following particulars only:

SECTION 1. Section 2.1 of the Agreement, as amended, entitled "Contract Sum" is amended to increase the maximum contract sum by Twenty Four Thousand Five Hundred Dollars (\$24,500). The maximum contract sum will increase from Twenty Five Thousand Dollars (\$25,000) to Forty Nine Thousand Five Hundred Dollars (\$49,500).

SECTION 2. Section 5.0 of the Agreement, is hereby amended to extend the Term for completion of services under the Agreement to June 30, 2021.

SECTION 3. Except as expressly provided for in this First Amendment, all other provisions of the Agreement shall remain in full force and effect.



# STAFF REVIEW

The limit for Fiscal Year 2020-21 has been calculated using the methodology and adjustment factors provided by the California Department of Finance. The adjustment factors used by the City are the per capita personal income change and the population annual change.

The appropriations limit for Fiscal Year 2020-21 is \$36,072,744. The City's budget appropriation subject to the limit is \$15,965,688. The City is well under the limit. Approval of Resolution CC-2006-034 will adopt the City's appropriations limit.

## BACKGROUND

Government Code (GC) Section 53607 allows the legislative body to delegate authority to invest or reinvest funds of the City to the City Treasurer for a one-year period subject to annual renewal. GC Section 53646 states that the City Treasurer may render a statement of investment policy to be considered at a public meeting.

## STAFF REVIEW

The attached Resolution CC-2006-036, *A Resolution of the City Council of the City of Lawndale, California, Reaffirming Council Policy Number 80-04 Pertaining to the City's Investment Policy*, is presented for the City Council's review and consideration. The City Council Policy has been reviewed and only grammatical changes are recommended by staff.

The Policy establishes investment authority jointly with the City Treasurer and the City Manager. It limits purchases to a five-year maturity, unless advance approval is obtained from City Council. The objective of investment decisions is to provide the highest yield possible, while safeguarding City cash assets and providing liquidity for operational needs. The Policy is conservative and follows guidelines set in the Government Code for allowable safe investment practices.

# PURPOSE:

The purpose of this statement is to comply with California Government Code (GC) Sections 16481.2, 53600, et seq., including 53646 and to provide clear guidelines for the prudent investment of the City of Lawndale's ("City") pooled cash assets.

# **OBJECTIVE**:

The City's cash management system is designed to accurately monitor and forecast expenditures and revenues, which enables the City to invest its funds to the fullest extent possible. The City attempts to receive the highest yield obtainable with investments which meet the criteria established for safety and liquidity.

# **POLICY:**

In compliance with GC Section 53600.3, the City manages its pooled cash assets under the Prudent Person Rule (Probate Code Section 16040, et seq., as defined on Exhibit "A".) This allows the City a number of investment options as long as the investment is deemed prudent, does not exceed five years to maturity (unless previously approved in advance of the investment by the City Council by resolution), and is allowable under current legislation (GC Section 53600, et seq.).

Criteria for selecting investments and the order of priority are:

1

- 1. <u>Safety</u>. Safety of principal is the foremost objective of the City. Each investment transaction shall seek to ensure that capital losses are avoided, whether from institution default, broker-dealer default or erosion of market value. The City shall seek to preserve principal by mitigating the two types of risk credit risk and market risk.
  - A. Credit Risk: Credit risk, defined as the risk of loss due to failure of an issuer of a security, shall be mitigated by investing only in very safe institutions and by diversifying the funds so that the failure of any one issuer would not unduly harm the City's cash position. Investments must be limited to securities backed by the full faith and credit of: (1) the federal government, (2) other governmental agencies,

or (3) agencies and institutions with collateral, including assets and insurance, assuring similar risk.

- B. Market Risk: The risk of market value fluctuations due to overall changes in the general level of interest rates shall be mitigated by limiting the weighted average maturity of the City's funds to no more than three years.
- 2. <u>Liquidity</u>. Liquidity is the second most important objective of the City. This refers to the ability to "cash in" at any moment in time with a minimal chance of losing some portion of principal or accrued interest. Liquidity is an important quality especially when the need for unexpected funds occurs.
- 3. <u>**Yield**</u>. The current rate of return on an investment generally expressed as a percentage of the securities current price. The City desires to obtain the highest possible rate of return consistent with the foremost objectives of safety and liquidity.

This policy will enhance the economic status of the City by (a) safeguarding the pooled cash assets of the City and (b) ensuring that the City receives the highest possible rate of return on its money commensurate with the priority of safety. The basic premise underlying the City's investment philosophy is to ensure City cash assets are always safe and available when needed.

# **INVESTMENT AUTHORITY**

The city treasurer and the city manager, acting jointly, are authorized to make investments on behalf of the City. Such investments shall be limited to the following instruments authorized under GC Sections 53601, 53635, 53684 and 16429.1 and further described in Exhibit "B":

- 1. Local Agency Investment Fund (LAIF) (state pool) demand deposits.
- 2. Certificates of deposit (or time deposits) placed with commercial banks and/or savings and loan companies and/or savings banks that are members of the Federal Depository Insurance Corporation (FDIC), not to exceed two hundred fifty thousand dollars (\$250,000) in any single account with the same institution to ensure security.
- 3. Passbook savings account demand deposits, not to exceed two hundred fifty thousand dollars (\$250,000) in any single account with the same institution.
- 4. Bonds, notes or other evidence of indebtedness of any local agency within the state or a department, board, agency or authority of the local agency.
- 5. Securities of the United States government or its agencies for which the full faith and credit of the United States is pledged for payment of principal and interest.

The following investments may only be made with the prior approval of the City Council by resolution, which approval must be renewed each year at the time of filing the annual Statement of Investment Policy:

2

- 1. Los Angeles County Treasurer's Municipal Investment Pool not to exceed 5% of the total county pool.
- 2. Money market mutual funds. Fund must receive the highest ranking by not less than two nationally recognized rating agencies or retain an investment advisor registered with the Securities Exchange Commission (or exempt from registration), have assets in excess of \$500,000,000, and at least five years' experience investing in instruments authorized by GC Sections 53601 and 53635.
- 3. Bankers' acceptances.
- 4. Small Business Administration loans.
- 5. Negotiable certificates of deposit.
- 6. Mortgage backed securities (GNMA, FHLMC, etc.).
- 7. Any investment of funds which, when aggregated with all other investments, will cause the investment in securities with a maturity greater than two years to exceed thirty percent (30%) of the total pooled City funds.

The city treasurer and the city manager shall purchase investment securities directly from the issuer or in accordance with GC Section 53601.5.

# INVESTMENT OF DEBT PROCEEDS, LEASES, REVENUE BONDS OR SIMILAR TRANSACTIONS

Proceeds of indebtedness, certificates of participation, revenue bonds, leases, or similar transactions held by a third party trustee pursuant to an agreement with the trustee shall be invested as described in the applicable authorizing document.

## **INELIGIBLE INVESTMENTS**

Investments not described herein, including, but not limited to, common stocks, commercial paper, repurchase agreements, reverse repurchase agreements, futures, options and derivatives are prohibited from use as City investment vehicles. The City also shall not make leveraged investments, investments made on margin or any other investment made possible through the use of funds borrowed exclusively for the purpose of financing investments.

## SAFEKEEPING OF INVESTMENT SECURITIES

3

To protect against potential losses caused by the collapse of individual securities broker/dealers all securities owned by the City shall be held in third party safekeeping by the trust department of the City's bank or other designated third party trust, in the City's name and control, under the terms of a custody agreement executed by the trust institution and the City. All securities will be received and delivered using standard delivery vs. payment (DVP) procedures to ensure the transfer of securities only happens after payment has been made.

# TRANSFER OF INVESTMENT FUNDS

The transferring of investment funds will be carried out by use of telephone or electronic wire transfers. Each entity with which the City does business shall receive, in writing from the city treasurer, a listing which limits transfers of funds to pre-authorized bank accounts only. The listing will also contain the names of the City staff authorized to request such transfers and will be updated, in writing, for all changes of authorized staff and bank accounts as necessary.

# **INSTITUTIONAL CRITERIA**

The City shall transact business only with banks, savings and loans, direct issuers and registered investment securities dealers.

The purchase by the City of any investment, other than those purchased directly from the issuer, shall be purchased directly from an institution licensed by the state as a broker/dealer, as defined in Section 25004 of the Corporations Code, who is a member of the National Association of Securities Dealers, or a member of a federally regulated securities exchange, a national or state chartered bank, a federal or savings association (as defined by Section 5102 of the Financial Code), or a brokerage firm designated as a primary government dealer or regional brokerage dealer by the Federal Reserve Bank.

Savings and loan and banking institutions with which the City shall deposit or invest its funds shall be financially responsible and meet, at a minimum, the following criteria:

- 1. The institution shall have been in business at least five (5) years.
- 2. Assets shall be greater than fifty million dollars (\$50,000,000).
- 3. Net worth to asset ratio shall be 3.5 to 1 or greater.
- 4. Subordinated debt shall not be considered part of net worth.
- 5. Deposits in certificates of deposit cannot exceed thirty percent (30%) of total portfolio.
- 6. Interest may be paid monthly, quarterly, semi-annually or annually and at maturity.
- 7. The institution shall submit audited financial statements.

# **REPORTING**

In accordance with GC Section 53646(b), the city treasurer shall render, at least quarterly, reports to the city manager and City Council showing: (a) type of investment, (b) institution, (c) date of maturity, (d) amount of deposit, (e) current market value, (f) rate of interest on each security, and (g) such other data as the City Council may, from time to time, specify.

01001.0001/651439.2 Resolution No. CC-2006-036 Exhibit "A" In accordance with GC Section 53646(a)(2), the city treasurer may annually render to the city manager and City Council a Statement of Investment Policy, which Council shall consider and adopt by resolution at a public meeting.

To ensure consistency with any new relevant legislation and financial trends, the city treasurer shall periodically report to the city manager and City Council proposed changes in the law and amendments to this policy for review and approval.

# EXHIBIT "A"

## PRUDENT PERSON RULE (California Probate Code)

## DIVISION 9, PART 4, CHAPTER 1, ARTICLE 2. TRUSTEE'S STANDARD OF CARE

#### 16040. Trustee's standard of care in administering trust.

- (a) The trustee shall administer the trust with reasonable care, skill, and caution under the circumstances then prevailing that a prudent person acting in a like capacity would use in the conduct of an enterprise of like character and with like aims to accomplish the purposes of the trust as determined from the trust instrument.
- (b) The settlor may expand or restrict the standard provided in subdivision (a) by express provisions in the trust instrument. A trustee is not liable to a beneficiary for the trustee's good faith reliance on these express provisions.
- (c) This section does not apply to investment and management functions governed by the Uniform Prudent Investor Act, Article 2.5 (commencing with Section 16045).

#### 16041. Standard of care not affected by compensation.

A trustee's standard of care and performance in administering the trust is not affected by whether or not the trustee receives any compensation.

## 16042. Public guardian's deposit or investment of trust property.

- (a) Notwithstanding the requirements of this article, Article 2.5 (commencing with Section 16045), and the terms of the trust, all trust funds that come within the custody of the public guardian who is appointed as trustee of the trust pursuant to Section 15660.5 may be deposited or invested in the same manner, and would be subject to the same terms and conditions, as a deposit or investment by the public administrator of funds in the estate of a decedent pursuant to Article 3 (commencing with Section 7640) of Chapter 4 of Part 1 of Division 7.
- (b) Upon the deposit or investment of trust property pursuant to subdivision (a), the public guardian shall be deemed to have met the standard of care specified in this article and Article 2.5 (commencing with Section 16045) with respect to this trust property.

# EXHIBIT "B"

# **DESCRIPTION OF INVESTMENTS**

Surplus funds of local agencies may only be invested in certain eligible securities. The City invests only in those allowable securities under GC Sections 53601, 53635, 53684 and 16429.1.

# LOCAL AGENCY-INVESTMENT FUND

LAIF investments are highly liquid with deposits being wired to the City within twenty-four hours and interest compounded daily.

LAIF is a special fund in the state treasury which local agencies may use to deposit funds for investment. There is no minimum investment period and the minimum transaction is \$5,000, in multiples of \$1,000 above that, with a maximum of \$65,000,000 for any agency. All interest is distributed to those agencies participating on a proportionate share determined by the amounts deposited and the length of time of the deposit. Interest is paid quarterly and deposited directly into the account on the 15th day of the month following the close of the quarter. The State keeps an amount for the reasonable costs of administration, not to exceed five percent of the quarterly earnings of the fund.

Interest rates are fairly high because of the pooling of the State surplus cash with the surplus cash deposited by local governments. This creates a multibillion-dollar money pool and allows diversified investments. In a high interest rate market, the City may produce higher yields than LAIF can, but in times of low interest rates, LAIF yields are generally higher.

# **CERTIFICATES OF DEPOSIT**

Certificates of deposit (CDs) are saving certificates with a fixed maturity date and specified interest rate that are generally issued by commercial banks in any denomination aside from minimum investment requirements. A CD restricts access to funds until the maturity date of the investment. If the money is withdrawn before the maturity date, there is a penalty for early withdrawal. Certificates of deposit typically range from three months to five years.

Certificates of deposit are insured for up to \$250,000 when made with members of the Federal Deposit Insurance Corporation (FDIC). CDs made above this amount with any one institution should be collateralized at 110% by the institution with government securities or 150% with mortgage-backed securities. The City will not purchase CDs in an amount exceeding \$250,000 at any given institution.

# PASSBOOK SAVINGS ACCOUNTS

Passbook savings accounts are demand deposits in major deposit and lending institutions that allow the investor to transfer money from checking to savings and earn short-term interest on odd amounts of money which are not available for longer investment. Passbook savings accounts are open-ended (i.e., they have no fixed term) and funds may be withdrawn at any time with no penalties. They are also insured up to \$250,000 when made with members of the FDIC. They are among the safest investments and earn very low rates of interest. Generally, because of the high degree of flexibility and the low yield, these investments are made with convenience as the objective rather than yield and are usually for small amounts.

# NOTES, BONDS AND LOANS OF LOCAL AGENCIES WITHIN THE STATE INCLUDING BOARDS AND AGENCIES OF A LOCAL AGENCY

These investments are loans directly to the City's successor to the Lawndale Redevelopment Agency and allow for a secure guaranteed rate of return that will be repaid from the Successor Agency to the Lawndale Redevelopment Agency's tax increments (property taxes). The Agency's Board (City Council) and City Council control the terms of any such loan arrangement.

# **U. S. TREASURY SECURITIES**

U.S. Treasury securities are considered the safest of all investments and are also highly liquid.

U.S. TREASURY BILLS are direct short-term debt obligations of the United States government. They have maturity dates of one year or less and are sold in denominations of \$1,000. They are issued and traded on a discount basis and the interest is computed on a 360-day basis. They are highly liquid investment with low market risk.

U.S. TREASURY NOTES are medium-term debt obligations of the United States government with fixed interest rates paid semiannually until maturity. Notes mature between one and 10 years (typical maturities are 2, 3, 5, 7 and 10 years). They are sold in multiples of \$100 with the minimum price of \$100. Although Treasury notes have low credit risk, they are affected by interest-rate and inflation risk which makes them volatile in a changing interest rate environment.

U.S. TREASURY BONDS are marketable, fixed-interest United States government debt security with a maturity of more than 10 years (typical maturities are 15, 20 or 30 years) and interest paid semiannually. These long-term bonds are highly volatile in a changing interest rate environment and are not considered low market risk investments.

# FEDERAL AGENCY SECURITIES

Federal agency securities are highly liquid and considered credit risk free. They are guaranteed directly or indirectly by the United States government. All agency obligations qualify as legal investments and are acceptable as security for public deposits. They usually provide higher yields than regular treasury issues with all of the same advantages. Examples are:

FNMA's (Federal National Mortgage Association) are used to assist the home mortgage market by purchasing mortgages insured by the Federal Housing Administration and the Farmers Home Administration, as well as those guaranteed by the Veterans Administration.

FHLB's (Federal Home Loan Bank) notes and bonds are issued by the Federal Home Loan Bank System to help finance the housing industry. The notes and bonds provide liquidity and home

mortgage credit to savings and loan associations, mutual savings banks, cooperative banks, insurance companies and mortgage lending institutions.

Other federal agency issues include Federal Intermediate Credit Bank Debentures (FICB), Federal Farm Credit Bank (FFCB), Federal Land Bank Bonds (FLB), Small Business Administration notes (SBA's), Government National Mortgage Association notes (GNMA's), Tennessee Valley Authority notes (TVA's), and Student Loan Association notes (SALLIE MAE's).

While these investments are virtually credit risk free, they must be held to maturity to receive the guaranteed principal and interest. They are subject to the same market risks as similar non-government securities and not ordinarily invested in by the City.

# LOS ANGELES COUNTY POOLED SURPLUS INVESTMENTS

The Los Angeles County Pooled Surplus Investments is similar to the California LAIF. The county fund provides protection, liquidity and higher than market rates for short-term securities.

Los Angeles County manages a multi-billion dollar portfolio serving local agencies, including school districts, community college districts, special districts and cities. This pooled fund is managed by the County Treasurer and interest is competitive to money market rates. There are no restrictions to the number of transactions or dollar amount of deposits. The funds deposited by a local agency in the county pooled fund cannot be impounded or seized by any county official or agency while the funds are so deposited.

All interest, less costs to administer the fund, is distributed to those agencies participating on a proportionate share determined by the amounts deposited and the length of time of deposit. Interest is posted quarterly to the pool.

## MUTUAL FUNDS

Money market mutual funds are another authorized investment allowing the City to maintain liquidity, receive competitive money market rates and remain diversified in pooled investments.

Mutual funds are referred to in GC Section 53601.6 as "shares of beneficial interests issued by diversified management companies registered under the Investment Company Act of 1940". The mutual fund must be restricted by its by-laws to the same investments allowed to the local agency. These investments are treasury issues, agency issues, banker's acceptances, commercial paper, certificates of deposit and negotiable certificates of deposit. The quality rating and percentage restrictions in each investment category applicable to the local agency also applies to the mutual fund.

The purchase price of shares of the mutual fund shall not include any sales commission. Investments in mutual funds and money market mutual funds cannot exceed twenty percent of the City's surplus money.

# BANKERS' ACCEPTANCES

Banker's acceptances are frequently the highest in yield among short-term investments, are relatively safe and are highly liquid.

Bankers' acceptances are short-term credit arrangements that facilitates international trade transactions between two parties when they do not have an established credit relationship. It is a time draft drawn on a bank by an importer to finance purchases. By its acceptance, the bank becomes primarily liable for the payment of the draft at its maturity. Acceptances are purchased in various denominations ranging from 30 to 180 days. The interest is calculated on a 360-day discount basis similar to treasury bills. The City may invest up to forty percent of surplus money in bankers' acceptances with up to thirty percent invested in any one commercial bank (GC Section 53601(g)).

# **NEGOTIABLE CERTIFICATES OF DEPOSIT**

Negotiable certificates of deposit (NCDs) are high-grade negotiable instruments, paying a higher interest rate than regular certificates of deposit. They are liquid because they can be traded in the secondary market. However, they cannot be cashed in before maturity.

Negotiable certificates of deposit are unsecured obligations of the financial institution, bank or savings and loan, generally bought at par value with a promise to pay face value plus accrued interest at maturity or the instrument is purchased at a discount to its face value. Minimum face value is \$100,000 with maturities ranging from two weeks to one year. The City does not usually invest in NCDs.

### BACKGROUND

Since 2001, Bericom Design has provided consistent professional information and technology services to the City of Lawndale over the last twenty years. The current contract will expire on June 30, 2020. Services are provided at an hourly rate of \$87.73 up to 1,628 hours annually (not to exceed \$142,824 annually).

### STAFF REVIEW

Bericom Designs has faithfully served the City of Lawndale for its information and technology service needs. Services have included network administration, hardware/software diagnostics and resolution, City website maintenance, system security, technical support and recommendations for hardware/software acquisition and retirement. In the past fiscal year, Bericom has assisted in the implementation of the online Business License portal, the selection of the City website design vendor, updating computers and/or their operating systems, implementing remote access and online meetings during the pandemic and assisted staff in numerous other tasks.

In the current economic environment, Bericom has agreed to the existing rate of \$87.73 per hour for the one-year contract extension. A one-year extension is requested to provide continuity in services over the next fiscal year, while having time to develop, solicit and review service proposals. Due to the duration of the existing contract, it is in the interest of the City to solicit information and technology services to ensure competitive costs and services are retained.

### LEGAL REVIEW

The City Attorney has reviewed the agreement and approved as to form.

### **FUNDING**

Information Technology Services are General Fund supported in the Information Systems Department under Contract Services (100-180-530.100), and are included in the Fiscal Year 2020-21 budget.

### THIRD AMENDMENT TO CONTRACT SERVICES AGREEMENT FOR INFORMATION AND TECHNOLOGY SERVICES

This THIRD AMENDMENT TO CONTRACT SERVICES AGREEMENT (the "Third Amendment") is made and entered into this 1<sup>st</sup> day of July, 2020, by and between the CITY OF LAWNDALE, a municipal corporation (herein "City") and Besim Berisha, a sole proprietorship, doing business as Bericom Design (herein "Consultant").

### RECITALS

WHEREAS, City and Consultant entered into that certain Agreement entitled "Contract Services Agreement for Information Technology Services" (the "Agreement") on or about December 5, 2011, and

WHEREAS, City and Consultant entered into that certain "First Amendment to Contract Services Agreement for Information Technology Services" (the "First Amendment") on or about April 21, 2014, and

WHEREAS, City and Consultant entered into that certain "Second Amendment to Contract Services Agreement for Information Technology Services " (the "Second Amendment") on or about April 17, 2017, and

WHEREAS, it is the desire of the City and the Consultant to perform services for an additional fiscal year, and

WHEREAS, the current contract will expire on or about June 30, 2020, and this amendment will extend the provisions of services through June 30, 2021.

### AGREEMENT

NOW, THEREFORE, it is hereby agreed that the Agreement, as amended, is further amended in the following particulars only:

SECTION 1. Section 2.1 of the Agreement, as amended, entitled "Contract Sum" is again amended to increase the maximum contract sum by One Hundred Forty-Two Thousand Eight Hundred Twenty-Four Dollars (\$142,824.00). The maximum contract sum will increase from One Million Two Hundred Ten Thousand, Seven Hundred Sixteen Dollars (\$1,210,716.00) to One Million Three Hundred Fifty-Three Thousand, Five Hundred Forty Dollars (\$1,353,540.00).

SECTION 2. Section 2.1 of the Agreement, as amended, and Exhibit "C" entitled "Schedule of Compensation" of the Agreement, as amended, is again amended to add thereto "Exhibit C-3, Third Supplemental Schedule of Compensation" to this Third Amendment, which exhibit is incorporated herein by this reference as if set forth in full.

SECTION 3. Section 3.4 of the Agreement, is hereby amended to extend the Term for completion of services for the agreement including this and all previous amendments to June 30, 2020.

### **RECOMMENDATION**

Staff recommends that the City Council approve the Third Amendment to Contract Services Agreement for Information and Technology Services with Bericom Design extending services for a one year term, July 1, 2020 through June 30, 2021 and to solicit proposals for services during Fiscal Year 2020-21.

### 4. <u>Annual Budget for Fiscal Year 2020-21</u>

Recommendation: that the City Council (a) consider and approve items 1 through 14 as listed in the staff report and incorporated into the proposed budget, and direct staff as appropriate; and (b) adopt Resolution No. CC-2006-028, approving and adopting the Citywide Budget for FY 2020-21 as amended based on direction provided by City Council in relation to items 1 through 14 as listed in the staff report.

Finance Director Marla Pendleton provided a general review of the proposed Annual Budget for Fiscal Year 2020-21.

City Manager Kevin M. Chun added follow-up remarks with respect to the budget process and commended Finance Director and the Finance Department.

A lengthy dialogue ensued between the City Council and Staff regarding adequate weekend coverage from Municipal Services Officers.

Councilmember Kearney recommended to reducing staff uniforms budget to \$1,000. Community Services Director Mike Estes concurred.

Councilmember Osborne inquired about potentially having Unarmed Security Service return if the budget improves. City Manager Kevin M. Chun and Community Services Director Mike Estes responded that it they would explore the possibility of a new company should funding be available.

A lengthy dialogue ensued between the City Council and Staff regarding management of parks with the Lawndale Elementary School District. A preliminary notice will be prepared.

The items listed as 1 through 14 were summarized as one motion to approve as follows:

- 1. In accordance with Personnel Rule 3.55 and the Memorandum of Understanding between the City of Lawndale and the respective employee bargaining units, implement an economic layoff of all part-time employees. Based on operational need, rehire staff to provide essential functions not to exceed the following annual budgeted amounts: Rec Leader/ Sr Rec Leader, Rec Leader/ Sr Rec Leader, Transit Operator, and Cable TV Prod. Assistant *Staff Recommendation Approved, Councilmember Kearney opposed the staff recommendation.*
- 2. Reduce the Recreation Program Uniform budget by \$1,500 from the \$3,000 request due to workforce reduction (277-510-510.500). *Staff Recommendation Amended budget reduced by \$2000 from the \$3000 request (\$1000).*
- 3. Reduce full-time staff in the Community Services Department to be in line with service requirements. Specifically, eliminate the below three authorized positions and funding to realize cost savings for the full fiscal year:
  - a. Community Services Supervisor
  - b. Community Services Coordinator
  - c. Recreation Coordinator

Staff Recommendation Approved.

- 4. Eliminate all travel and training budgets Citywide leaving funding for only Citywide mandatory human resources training of \$2,000 (100-150-510.610). If funding becomes available during the fiscal year, consider reinstating funding based on operational needs. *Staff Recommendation Approved.*
- 5. Eliminate School Crossing Guard Services. Estimated costs of \$132,405 was removed from the proposed budget (100-510-530.100). The existing contract with All City Management Services, Inc. expires on June 12, 2020. Direct staff to inform All City Management Services that the existing contract will not be renewed in Fiscal Year 2020-21. *Staff Recommendation Approved*.
- 6. Discontinue Unarmed Security Services for the Harold E. Hoffman Community Center, City Hall Courtyard, Veteran's Memorial Wall and surrounding parking lots. Section 2.3 of the agreement between the City of Lawndale and the Alpha and Omega Group Security Services, Inc. allows the City the option to void or amend the existing agreement to reflect unanticipated reduction in funding for any reason. Section 7.4 further requires a thirty (30) day written notice for contract termination. Direct staff to terminate the existing contract with Alpha and Omega Group Security Services, Inc. effective July 1, 2020. The \$26,000 requested funding has been removed from the proposed budget for Fiscal Year 2020-21. *Staff Recommendation Approved*.
- 7. Reduce the requested funding for the Public Works Department Grounds Maintenance (100-320) to the actual amount expended in Fiscal Year 2018-19. Below are the accounts and amounts reduced in the proposed budget which results in a savings of \$37,500. *Staff Recommendation Approved*.
- 8. Reduce the existing Citywide tree trimming, pruning and tree removal service contract with South Bay Landscaping, Inc. for Fiscal Year 2020-21 by \$80,000 from the current year contract amount of \$166,490. Direct the Interim Public Works Director to review the 2020 Phase II Schedule included in the service contract and perform a risk assessment to identify specific trees which can be eliminated from the current year schedule without jeopardizing public safety or altering the aesthetic look of the City. *Staff Recommendation Approved*.
- 9. Reduce the budgeted funding for Senior Travel Club support from \$21,000 to \$10,000. The reduction has been incorporated into the proposed budget under the Senior Program Fund 278, Contract Services account 530.100. *Staff Recommendation Approved*.
- 10. Defer the \$43,400 one-time funding budget request for contract services to establish a transition plan for identifying and establishing a plan for compliance with the 2010 Americans with Disabilities Act (ADA) Standards for Accessible Design (100-160-530.100). *Staff Recommendation Approved*.
- 11. Transfer eligible costs from the Community Services Recreation and Senior Activities budgets to the newly awarded Community Development Block Grant- COVID-19 (CD BG-CV) grant and establish a \$5,000 budget for grant administrative costs (214-440-530.200). *Staff Recommendation Approved.*
- 12. Provide the required one year notice to cancel the Community Recreation Program Agreements with the Lawndale Elementary School District to renovate, operate and maintain the three school district parks located at the William Green, Jane Addams and William Anderson/ Will Rogers schools. Although this action will not provide savings in Fiscal Year 2020-21, it will provide approximately \$130,000 annually in water, electricity, and grounds maintenance annually after notice is given. In addition, part-time salaries of \$120,000, if approved under recommendation 1, could be saved annually for staffing the three parks. *Staff Recommendation Amended prior to giving formal notice, attempt to enter*

into negotiations with school district (suggested deadline to enter into an agreement of July 1, 2020, notice to be served if no deal reached to give back 1 or more schools).

- 13. Consider reducing the Lawndale Beat services from two routes down to one route. The Lawndale Beat is funded through Proposition A tax revenue, which is earmarked for the Local Return Program to be used by the City for developing and/or improving local public transit, paratransit and related transportation infrastructure. Estimated revenue for Fiscal Year 2020-21 is \$698,280 of which \$491,180 of appropriations was requested and included in the proposed budget for contract services to operate the two Lawndale Beat routes. If one route is eliminated, the funding will need to be reallocated into other authorized program uses. Direction is requested for this recommendation. *Staff Recommendation Approved Direction provided to eliminate the "express route" and keep the "residential route"*.
- 14. Increase the Unemployment Insurance Budget from \$50,000 to \$93,340 (100-160-525.600). *Staff Recommendation Approved.*

A motion by Councilmember Osborne to consider and approve items 1 through 14 as listed in the staff report, subsequently amended by City Council, and incorporated into the proposed budget, and direct staff as appropriate, and adopt Resolution No. CC-2006-028, approving and adopting the Citywide Budget for Fiscal Year 2020-21 as amended based on direction provided by City Council in relation to items 1 through 14 as listed in the staff report, subsequently amended by City Council, was seconded by Councilmember Kearney and carried by a vote of 5-0.

### BACKGROUND:

The General Plan Annual Progress Report (APR) summarizes the City of Lawndale's progress towards implementing the goals, policies, and programs of the City's General Plan. It covers the period from January 1, 2019 through December 31, 2019. The report also reviews the activities of the Community Development Department including the Planning, Building and Safety, and Housing divisions.

This report is prepared in compliance with California Government Code Section 65400(a), which mandates that all cities and counties submit to the Governor's Office of Planning and Research (OPR) an Annual Report on the status and implementation of the General Plan.

The City of Lawndale's General Plan includes nine elements – seven mandated elements and two optional elements (Air Quality and Economic Development). The Community Development Department maintains the General Plan and monitors its implementation. The Planning Commission and the City Council oversee the effectiveness and relevancy of the General Plan, and its implementation activities, through its annual review.

This Annual Report also describes the City's progress in meeting its regional housing needs over the current reporting period and describes local efforts to remove government constraints on the maintenance, improvement, and development of housing to satisfy Government Code § 65400 (b)(2). The California Department of Housing & Community Development (HCD) requires specific information related the development of housing in the City. This detailed information is summarized in the tables attached to this staff report.

### ANALYSIS:

The Annual Progress Report provides a brief summary of General Plan related actions undertaken during the reporting period. The following is a summary of major activities during the reporting period:

• There were 3,024 recorded counter visits to the Community Development Department; 124 site plan reviews were performed; 849 building permits were issued.

2019

- Adopting an urgency ordinance for Shared Mobility Devices, which establish rules and regulations prohibiting renting and storing of shared motorized scooters from public rights-of-way within the City.
- Through the reporting period many new major businesses opened within City boundaries, reducing the amount of vacancies for commercial spaces, as well as meeting the General Plan and Specific plan goals and objectives. Some of the businesses that opened in 2019 were; a Target store, a Pep Boys, an Appliance Liquidation store and Combinations boxing studio. Project approvals still in process include a 7-Eleven convenience store and a dental office on the second floor of a building with retail spaces for rent on the bottom, both projects are in the construction phase.

In the past, the Planning Commission has requested that staff make recommendations for ways to further implement the General Plan. The items listed below would all qualify as ways of implementing the General Plan:

- <u>PREPARE RESIDENTIAL DESIGN GUIDELINES.</u> Recently completed. The Residential Development Standards and Design Guidelines help ensure the quality of residential development, ensure that new development is compatible in mass, scale and other design features with surrounding developments; and assist residents property owners, developers and designers in understanding and implementing the principles contained in the document.
- 2) <u>COMPLETE REVISION AND MODERNIZATION OF ZONING CODE.</u> Efforts are ongoing. The most recent revision includes the Shared mobility devices regulations. The City is up to date with new zoning regulations and updates the City Zoning Code regularly.
- 3) <u>UPDATE THE HOUSING ELEMENT.</u> The housing element was updated in 2013 and covers the period from July 1 2014 June 30, 2021. The Community Development Department is currently working on a General Plan Amendment which includes the Housing Element.
- 4) INCREASE INCENTIVES FOR COMMERCIAL AND RESIDENTIAL LOT <u>MERGERS</u>. Applications are handled on a case by case basis.
- 5) <u>PREPARE SPECIFIC PLANS FOR MARINE AVENUE AND MANHATTAN BEACH</u> <u>BOULEVARD TO REALIZE THE ECONOMIC POTENTIAL OF EACH CORRIDOR.</u> Efforts are ongoing. The Community Development Department is currently working on updating the General Plan as well as the Hawthorne Boulevard Specific Plan.
- 6) <u>COMPREHENSIVE PLAN TO REDUCE URBAN RUNOFF IN LAWNDALE</u>. Efforts are ongoing.
- 7) <u>UPDATE CEQA GUIDELINES FOR DEVELOPMENT</u>. Recently completed. The CEQA Guidelines were prepared and adopted in 2018, no new updates have been incorporated.

### ENVIRONMENTAL ASSESSMENT:

The General Plan Annual Progress Report is exempt from the requirements of the California Environmental Quality Act (CEQA) under the general rule of CEQA Guidelines, Section 15061 (b)(3), that there is no possibility that the APR may have a negative physical impact on the environment.

### COMMISSION REVIEW:

At a public hearing on May 13, 2020, the Planning Commission adopted Resolution No. 20-07 recommending that the City Council review and adopt the 2019 General Plan Annual Progress Report.

### PUBLIC REVIEW:

Notices of a public hearing were posted on the bulletin board outside City Hall and published in the *Daily Breeze* on May 18, 2020.

### LEGAL REVIEW

The City Attorney's office has reviewed and approved Resolution No. CC-2006-035 as to form.

### FISCAL IMPACT

### **RECOMMENDATION**





#### Lawndale Background



Incorporated in 1959, the City of Lawndale is a small but highly urbanized community located in the South Bay portion of Los Angeles County, approximately 3 miles east of the Pacific Ocean. Although Lawndale only encompasses approximately two square miles, the community is home to nearly 33,500 residents with very few parcels of remaining vacant land. Surrounding communities include the cities of Hawthorne to the north, Redondo Beach to the west, and Torrance to the south. The City is well served by several regional transportation systems, including the San Diego (405) Freeway and Hawthorne Boulevard (107 Highway), which both pass through the community and provide access to major employment centers in Los Angeles County.

The City of Lawndale has grown from its predominately agricultural roots to a built-out City that is centrally located in the South Bay area, evolving into a bedroom community primarily consisting mostly of medium-density residential development.



### 2. Community Development Department

The Community Development Department is responsible for the review of development and building activity to ensure compliance with zoning and building codes, General Plan policies, the California Environmental Quality Act , and community values. The Department provides information to the general public on zoning, building, housing, redevelopment and economic development related matters; assists the community in establishing land use plans; ensures the quality of new projects through the development review process; and provides staff support to the Planning Commission, City Council, and the general public.

Counter activity is the number of counter visits recorded in the Department, which are kept and tracked on a monthly basis. Total *recorded* counter visits for 2019 were **3,024 visits**, which was much lower in comparison to the previous year which had **4,420** visits.


#### **Planning Division**

The Planning Division is responsible for two key functions: current planning and advanced planning. It is the Division's goal to provide timely and effective management of these two functions. Current planning involves the processing and review of various development applications for conformance with the City's Zoning Ordinance, General Plan, Specific Plan, and other land use policies. The Planning Division is responsible for reviewing applications and issuing permits pertaining to:

- Residential, commercial, and industrial design reviews
- Special Use Permits
- Subdivisions
- General proposed development

In 2019, the Planning Division processed **124** site plan review applications and **115** residential property reports, and brought **46** cases (e.g., SUPs, zoning code amendments) before the Planning Commission.





Advanced planning involves the City's long-range planning activities, which include updating and preparing various planning documents such as Specific Plans, the City's General Plan, and implementation of text amendments. Planning staff also assembles and maintains community data and demographics and coordinates the reporting of this data to outside agencies.

#### **Building and Safety Division**


The Building and Safety Division is responsible for a variety of tasks including issuing permits, processing plan check submittals, and inspections. The Building and Safety Division reviews all plans and permits for compliance with the California Building Code. New building construction and a majority of tenant improvements require plan check review for Zoning and Building Code compliance. These plan checks are reviewed by the Building and Safety Division, the Planning Division, the Fire Department, and the Engineering Division.

In addition to reviewing plans, the Building and Safety Division also issues permits. These types of permits include all construction related projects (residential, commercial, and industrial), grading, roofing, installation of mechanical and utility equipment, etc. **The total number of permits issued in 2019 was 849**, which is down (0.97%) from the 875 permits issued in 2018. This is off from the high of 920 permits issued in 2006, but construction has stabilized and appears to be making a steady recovery.

#### City of Lawndale



#### **Housing Division**

Activity in the Housing Division slowed dramatically following the dissolution of the Redevelopment Agency which helped fund many of the City's housing programs. Although these programs were effectively on hold during the reporting period, the City is hoping in the near future to reintroduce the Great Neighborhoods Program with the injection of new housing funds provided from the Housing Division. Additionally, the City has received some set aside funds from the CA Department of Finance for the development of affordable housing projects. The City intends on using set aside funds in developing affordable housing incentives for developers.

#### 3. General Plan Implementation Status

In preparation for a comprehensive update of its 1992 General Plan, the City of Lawndale appropriated funds in the fiscal year 2007-2008 budget for an evaluation of the General Plan. However, just as the housing crisis and economic downturn necessitated many cities to implement austerity measures, the City of Lawndale was also affected and forced to cut the appropriation from its general fund for the General Plan update.

The City recently sold a property located in the corner of Hawthorne Blvd. and Manhattan Beach Blvd. The City was able to apply the funds obtained from this transaction to hire a consultant to update both the General Plan and the Hawthorne Boulevard Specific Plan. The update's intent is to refresh the existing documents which the City view as relevant documents. The updates are expected to guide and maintain the City of Lawndale for the next 20years.

#### General Plan Amendments and Implementation Activities

The following represents the progress the City of Lawndale made towards implementing the goals and guiding policies of the General Plan during the reporting period.

#### Land Use Element

The Land Use Element establishes the policies for determining where certain land uses, such as residential, commercial, and industrial, are most desirable. The Land Use Element defines the physical areas in the City serving the needs of residents, businesses, and visitors.

# Policy 6g. The City shall protect, encourage and where feasible, provide housing opportunities for low and moderate income households, as well as for the homeless.

In 2019 the City continued to implement the accessory dwelling unit ordinance that allows accessory dwelling units on properties that are already developed with a single family residence. The intent of the accessory dwelling unit ordinance is to allow additional housing alternatives in which property owners could rent out accessory dwelling units, and provide opportunity to increase homeowner income, while helping to ease the high cost of living within the City. The City adopted new density bonus regulations that re-defined concessions and incentives for affordable housing projects consistent with state law. As a part of the ordinance additional concessions and incentives were allowed for housing

projects that provided housing for foster youth, disabled veterans, and homeless persons. The ordinance also allowed parking reductions if certain conditions are met regarding the proximity to major public transit stops.

Additionally an ordinance was adopted to ban short term rentals as well as a new ordinance to prevent landlords from evicting tenants before the new rent control ordinance came into effect in 2020

Implementation Program 5.1. Zoning Ordinance Update. During the reporting period, the Planning Commission undertook the review of a number of zoning code regulations in order to ensure that the zoning code reflects the City's community enhancement goals and policies. New regulations regarding the prohibition of shared mobility devices within City boundaries were adopted and approved by the Lawndale City Council. The key objectives and main components of the shared mobility devises ordinance included the following:

- Establishes rules and regulations prohibiting renting and storing of shared motorized scooters in public rights-of-way within the City.
- 45-day moratorium prohibiting the operation of motorized scooter programs within the City limits.
- On February 4<sup>th</sup>, 2019, the moratorium was extended by an additional 10-months 15 days.

The new Lawndale Municipal code section 12.60, was amended by Ordinance 1157 and its intent is to regulate shared mobility devices.

#### **Development Activity**

Building activity has remained relatively steady throughout the reporting period. Within the reporting period, permits were issued for 51 new dwelling units, an increase in units compared to 20 built in 2018. Nonetheless, most of the development activity within the reporting period came from property owners that were active with additions and remodeling projects.

Furthermore, tenant improvements to commercial properties remained fairly steady with six (6) permits issued for commercial tenant improvements. This is a slight decrease of four (4) tenant improvement project in comparison to the ten (10) tenant improvement permits that were issued within 2018. The table below identifies major development applications processed during the 2019 reporting period.

#### **<u>Circulation Element</u>**

The safe and efficient movement of people and goods through cities is provided by a circulation system ranging from sidewalks to bikeways to roadways. As population and economic growth continue, cities have the challenge of improving the circulation system to deal with increased demands. The growth also impacts the infrastructure required to provide utilities and other services needed for those who live, work, and visit the City.

**Goal 3. Roadway Improvements.** Improvements to streets and sidewalks are heavily favored in the City's 5-Year Capital Improvement Plan (CIP) for the period FY 17/18 - FY 21/22. The CIP has established priorities for street improvements, identifying areas of greatest need and coordinating short and long-range planning efforts. Road segment improvements that were either in design, under construction, or closed out during the reporting period included the following:

- 1. Inglewood Avenue Phase III
- 2. Traffic Signal Inventories
- 3. Underground Storage Tank Environmental Testing
- 4. City Maintenance Yard Parking Lot Pavement
- 5. Citywide Concrete Repairs
- 6. Burin House Demolition & Parking Lot Improvements
- 7. Traffic Speed Survey
- 8. Renamed 147<sup>th</sup> Street to Lawndale Way
- 9. Removed Marquee from Hawthorne Blvd



One major street improvement project that kicked-off in 2011 and continued in the planning and design phase throughout 2019 was the Inglewood Avenue corridor widening. This project has regional significance and involves multi-jurisdictional coordination between the cities of Lawndale, Redondo Beach, and Hawthorne. The road widening will significantly improve traffic circulation along Inglewood Avenue north of Manhattan Beach Boulevard and the associated intersection improvement at Inglewood Avenue will greatly improve the Level of Service (LOS) at that intersection.

#### Housing Element

The Housing Element establishes the City's housing policies and programs. It serves as a guide for City officials in decision-making and sets forth an action plan to implement the City's housing goals. The Housing Element is intended to direct residential development and preservation in a manner consistent with the General Plan and the requirements of State Housing Element law. The current Housing Element covers the period from July 1, 2014 – June 30, 2021.

Housing Element implementation is further discussed in Section 4. Housing Element Activity.

#### **Economic Development Element**

Throughout the reporting period the City made efforts to decrease the vacancy rate within the City's commercial zones. New businesses such as Target, Pep Boys, Combinations Boxing Academy, and a new Appliance Liquidation Store were opened for business during the reporting period. The department is making ongoing efforts to facilitate the approval process for new businesses while complying with all local, state and federal regulations.

#### **Open Space Element**

Typical of most communities located within mature urbanized settings, Lawndale has a limited amount of open space areas. Open space areas are important not only to provide recreational activities for residents, but also as a visual break from the built environment.

**Goal 1. Open Space**. The City currently has seven parks that offer recreational activities for the residents. Although no new parks were constructed during the reporting period, the City has made ongoing efforts to preserve existing parkland by providing continued maintenance of and improving existing park facilities.

#### **Conservation Element**

**Goal 1. Water Conservation.** In December 2013, the City Council adopted a resolution affirming its commitment to the implementation of low impact development controls for new development projects and towards establishing a "Green Streets" policy to reduce 10

storm water runoff discharges from municipal streets to receiving waters. During the reporting period the City continued to implement low impact development controls for all new construction and remodel projects.

Goal 3. Energy Conservation. To minimize negative environmental effects of supplying and using energy by reducing the community's reliance upon traditional energy resources through the initiation of energy conservation practices and the utilization of available energy technology.

During the 2019 reporting period the City with coordination with the South Bay Cities of Governments continued to follow the adopted Climate Action Plan ("CAP"). The CAP serves as a roadmap and guidance document for reducing GHG emissions within City operations and the community at large. The CAP includes a list of non-binding goals, measures, and sub-strategies for the possible emission reductions by sector to reach the City's GHG target for 2020. The forecast continues to describe the impacts of these strategies on the City's target for the year 2035.

#### Air Quality Management Plan

Due to the nature of the guiding and implementing policies of the Air Quality Management Plan, the efforts to implement this element of the General Plan are ongoing. Projects are reviewed on a case-by-case basis for adverse air quality impacts to the environment and sensitive receptors.

#### Safety Element

Natural and non-natural hazards present a variety of risks to persons who live, work, and visit the City. The City aims to reduce the potential risk of death, injuries, property damage, and the economic and social dislocation resulting from hazards.

In 2012, the City applied for grant funding through the State of California 2008 Disaster Recovery Initiative Program, which is under the Community Development Block Grant Program. This application was made to update the Safety Element and the City's Local Hazard Mitigation Plan. In January 2013, the City received notice that funding had been awarded in the amount of \$250,000. Accordingly, the Safety Element and the local hazard Mitigation Plan were updated and adopted in August of 2016. During the reporting period, efforts have been undertaken to initiate the further update of the Safety Element and the Local Hazard Mitigation Plan.

Due to the nature of the guiding and implementing policies of the Safety Element, the efforts to implement this element of the General Plan are on-going. Projects are reviewed on a case-by-case basis. Additionally, staff receive training in emergency preparedness and local hazard mitigations on an annual basis.

#### <u>Noise Element</u>

Due to the nature of the guiding and implementing policies of the Noise Element, the efforts to implement this element of the General Plan are on-going. Projects are reviewed on a case-by-case basis for adverse noise impacts to the environment and sensitive receptors, and the City continues to enforce its noise ordinances.

#### 4. Housing Element Activity

The 2014-2021 Housing Element is designed to address the existing and projected housing needs across all economic segments of the community. The City Council adopted the 2014-2021 Housing Element in January 2014 after the HCD notified the City that the draft Housing Element was found to be in compliance with State housing law.

During the reporting period the Community Development Department continued implementing the Housing Element's Housing Plan. This included the ongoing implementation of programs for housing conservation, production of housing, provision of adequate housing sites, removal of governmental constraints, and promotion of equal housing opportunity.

## Regional Housing Needs Assessment ("RHNA")

The current RHNA Plan was adopted by the Southern California Association of Governments (SCAG) Regional Council in July 2013. Under the RHNA Plan, each of the SCAG jurisdictions received an allocation of new housing units, which they are expected to facilitate the construction of during the 2014-2021 assessment period. There are many ways to "facilitate" construction of these units. At a minimum, each jurisdiction is expected to provide land zoned to accommodate housing at the densities required to provide the total number of units and meet the affordability requirements mandated by State law. Table B (attached) shows the progress made towards fulfilling the RHNA allocation including the number of residential development projects completed in the City from January 1, 2019 – December 31, 2019, categorized by income level.

## Affordable Housing Categories and Income Limits

Affordable housing is broken down into four categories. Each category is based upon a percentage of median income for Los Angeles County, adjusted for household size. The income limits are updated annually by the U.S. Department of Housing and Urban Development and form the income eligibility limits used by the HCD. These household income limits, as defined by California Housing Element law, are:

- Very Low: Households earning less than 50% of median family income
- Low: Households earning 51% to 80% of median family income
- Moderate: Households earning 81% to 120% of median family income
- Above Moderate: Households earning over 120% of median family income

Qualifying income limits for each group are based on household size. HCD determined annual gross income limits for Los Angeles County households in 2019 are shown below.

## Housing Production in Context with City Housing Policy

Production of affordable housing is facilitated by means of several specific City policies and housing programs. Primary City housing programs include the Rental Rehabilitation Program, Acquisition and Rehabilitation Program, Condominium Conversion Ordinance, Affordable Housing Development Program, Accessory Dwelling Unit Ordinance, and Density Bonus Ordinance. However, many of these programs have been severely impacted by the loss of Redevelopment Agency Housing Set-Aside funds and are effectively on hold until new funding sources can be secured.

#### 2014-2021 RHNA Production Summary

For the current RHNA cycle, 50 total units have been constructed (i.e., Certificate of Occupancy issued). Of those units, zero (0) fall within the affordable categories. During the reporting period, nine (9) new units were constructed.

#### **Housing Production Expectations**

Near term efforts in the present RHNA cycle will continue to focus on identifying underutilized sites for higher density mixed-use and affordable housing development. Information collected on economic development strategies and during the 2014-2021 Housing Element Update provided a starting point for identifying the vacant and underutilized sites, which are anticipated to provide the land necessary to sufficiently meet the current RHNA allocation. Combined with other affordable housing development efforts, such as density bonus incentives, residential second unit construction, development of accessory dwelling units and non-profit projects, the City is capable of meeting the established RHNA target for the current housing cycle.

SUBJECT:	November 3, 2020 General Municipal Election – Calling for the Election, Requesting County Consolidation and Services, and Adopting Regulations for Candidates Statements

### BACKGROUND

On April 17, 2017, the City Council adopted Ordinance No. 1135-17, changing the date of the City's General Municipal Election from April to November of even-numbered years, beginning in 2018, to be consolidated with the Statewide General Election. This year's Statewide General Election is scheduled to be held on November 3, 2020.

There are two City Council seats open in this election for a full term of four years; the seats are currently held by City Councilmembers James Osborne and Daniel Reid. The election is also for the position of Mayor for a full term of two years; the seat is currently held by Mayor Robert Pullen-Miles.

#### STAFF REVIEW

Resolutions must be adopted by the City Council prior to the election to: 1) call and give notice of the election, 2) establish regulations regarding candidates statements, and 3) request that the Los Angeles County Board of Supervisors consolidate the General Municipal Election with the statewide general Election.

#### Calling and Giving Notice of the Election

By adopting Resolution No. CC-2006-031, the City Council will order the General Municipal Election to be held on November 3, 2020.

The resolution also orders the following: 1) that the conduct of the election and the form and content of ballots be in accordance with state law; 2) that the election official procure all supplies necessary to lawfully conduct the election; 3) designates the Assistant City Clerk as the an election's official; and 4) that vote centers will be open from 7:00 a.m. until 8:00 p.m. on Election Day, which are the normal hours for Los Angeles County vote centers.

## Consolidating the Election with the Statewide General Election

Resolution No. CC-2006-032 will consolidate the General Municipal Election with the Statewide General Election, to be held on November 3, 2020. This resolution accomplishes the following: 1) requests that the Los Angeles County Board of Supervisors consolidate the General Municipal Election with the Statewide General Election, 2) directs the County Election Department to conduct the election, and 3) authorizes the County Election Department to perform the election canvass.

In a consolidated election, the majority of the duties normally performed by the City's election's official are managed by the County Registrar of Voters. These include consolidating precincts, establishing vote centers or polling places, recruiting and training precinct officers, furnishing precinct supplies, printing and mailing voter pamphlets (sample ballots), printing official ballots, conducting the election tally and staffing the tally center, canvassing the election returns and certifying the official Election results. The City's election official will retain the following responsibilities: Conducting the nomination process, publishing and posting legally required notices and furnishing copies of ballot materials to the Los Angeles County Registrar Recorder.

#### Candidates Statements

Resolution No. CC-2006-032 establishes the regulations and limits to Candidate Statements that will appear in the voter pamphlet.

The California Election's Code allows candidate statements to include the name, age and occupation of the candidate and a brief description of the candidate's education and qualifications. The statement may not include the candidate's party affiliation, the candidate's membership or activity in partisan political organizations, or reference to other candidates for the same office. All statements are printed in type of uniform size and darkness, with uniform spacing. State law also allows local jurisdictions to establish policies pertaining to:

- Length of the candidate's statement
- Foreign language translations
- Payment for the cost of printing, handling, translating and mailing candidate statements

If approved by the City Council, the attached resolution will acknowledge the requirements and restrictions in state and federal laws. The specific provisions are as follows:

- Length of Statement State law restricts the length of the candidate statement to 200 words, but also authorizes the City Council to increase the limit to 400 words. Since Lawndale traditionally chooses not to raise the limit, the resolution is written to again limit statements to 200 words.
- Foreign Language Translations A candidate may request that the statement also be printed in Spanish and included in the Official Sample Ballot Booklet mailed to all voters in the election area. An additional fee is required to print a Spanish candidate statement. In compliance with California Law, (Election Code Section 13307 (b)) the Los Angeles County Registrar/Recorder Office will only print English and Spanish candidate statements to be included in the Official Sample Ballot Booklet for candidates who wish to have one, at the candidate's own expense.
- Multilingual translation for candidate statements for Voter Information Booklets may be provided in Vietnamese and Korean for qualified jurisdictions in accordance with Federal Voting

Rights Act provisions and Department of Justice specifications. These materials when printed are sent only to voters who have requested them.

Payment for the Cost of the Statement - State law allows the City/County to pass on the cost of translating, printing, handling, and mailing candidate statements to the candidates. The estimated cost for the 2020 Election candidate statements has not been produced as of yet, however the estimated cost for the 2108 Elections was \$800 each. A small number of cities require candidates to pay all costs except translations required by the federal and state voting rights acts. Multi-lingual Sample Ballot printing and translation would be included in the cost estimate. Per the Los Angeles County Registrar-Recorder/County Clerk, sample ballots will be mailed in English and Spanish. Other languages are available if requested by the voters. Due to the fact that Lawndale candidates have always paid all costs, we have written the resolution accordingly. Please note that in previous elections, Los Angeles County only charged for printing costs, but moving forward, they will now base candidate statement fees on mailing and handling costs in addition to the printing costs.

Staff recommends that the City Council review all options presented. As stated above, the proposed resolution does not substantially reflect any changes in policy from past elections. If the City Council support keeping the status quo with regard to candidate statement regulations, staff recommends that you adopt the resolution as written.

## LEGAL REVIEW

The City Attorney has reviewed the attached resolutions and approved them as to form.

## FISCAL IMPACT

The Fiscal Year 2020-21 Budget includes funding in the amount of \$88,000. At this time, we do not anticipate the need for an additional appropriation.

#### RECOMMENDATION

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, CALLING FOR THE HOLDING OF A GENERALMUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 3, 2020, FOR THE ELECTION OF CERTAIN OFFICERS, DESIGNATING THE ELECTION OFFICIAL, AND OTHER MATTERS AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING TO GENERAL LAW CITIES

WHEREAS, under the provisions of the laws relating to general law cities in the State of California, a General Municipal Election shall be held on November 3, 2020, for the election of a Mayor for the full term of two years; and two members of the City Council of said City for the full term of four years; and

WHEREAS, pursuant to Lawndale Municipal Code Section 2.16.030, the City Council shall designate an individual to serve as the City's Election Official in conjunction with the resolution necessary to call each election; and

WHEREAS, pursuant to California Elections Code Section 12303, all political jurisdictions in the state are obligated to encourage non-English speaking citizens to vote and to minimize obstacles to voting by such citizens and, therefore, must provide minority language assistance when three percent or more of voting-age residents of a precinct are non-English speaking citizens; and

WHEREAS, pursuant to California Elections Code Section 10242, the City Council shall establish and determine the hours vote centers will be open.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. That pursuant to the requirements of the laws of the State of California relating to general law cities, there is called and ordered, to be held in the City of Lawndale, California, on Tuesday, November 3, 2020, a General Municipal Election of the qualified electors of Lawndale for the purpose of electing a Mayor for the full term of two years; and two members of the City Council for the full term of four years.

SECTION 2. That pursuant to Lawndale Municipal Code Section 2.16.030, the Assistant City Clerk is hereby designated as the Election Official in and for the City of Lawndale, in connection with all proceedings related to the Election called for herein, who shall be responsible for all duties, either express or implied, in conjunction with conducting the November 3, 2020 General Municipal Election.

SECTION 3. That notice of the time and place of holding the Election is given and the Election official is authorized, instructed and directed to give further or additional notice of the Election, in time, form and manner as required by law.

SECTION 4. That the Elections Official is authorized, instructed and directed to coordinate with the County of Los Angeles-Recorder/County Clerk to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the Election. That the ballots to be used at the Election shall be in form and content as required by law.

SECTION 4. That the vote centers for the Election shall be open at seven o'clock a.m. of the day of the Election and shall remain open continuously from that time until eight o'clock p.m. of the same day when the vote centers shall be closed, pursuant to Election Code Section 10242, except as provided in Section 14401 of the Elections Code of the State of California.

SECTION 5. That in all particulars not recited in this resolution, the Election shall be held and conducted as provided by law for holding Municipal Elections.

SECTION 6. That notice of the time and place of holding this Election is hereby given and the Assistant City Clerk is authorized, instructed and directed to give such further or additional notice of the Election in time, form and manner as required by law.

SECTION 7. That in the event of a tie vote (if any two or more persons receive an equal and the highest number of votes for an office) as certified by the County of Los Angeles Registrar-Recorder/County Clerk, the City Council, in accordance with Election Code Section 15651(a), shall set a date and time and place and summon the candidates who have received the tie votes to appear and will determine the tie by lot or in accordance with Election Code Section 15651(b), shall conduct a Special Runoff Election to resolve the tie vote and such Special Runoff Election is to be held on a Tuesday not less than 40 days nor more than 125 days after the administrative or judicial certification of the Election which resulted in a tie vote.

SECTION 8. The City Council authorizes the County of Los Angeles Registrar-Recorder/County Clerk to administer said Election and all reasonable and actual Election expenses shall be paid by the City upon presentation of a properly submitted bill.

#### **RESOLUTION NO. CC-2006-033**

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, ADOPTING REGULATIONS FOR CANDIDATES FOR ELECTIVE OFFICE WITH RESPECT TO CANDIDATES STATEMENTS SUBMITTED TO THE VOTERS AT AN ELECTION TO BE HELD ON TUESDAY, NOVEMBER 3, 2020

WHEREAS, the City Council has called for a General Municipal Election to be held on November 3, 2020 for the Election of a Mayor and two members of the City Council; and

WHEREAS, pursuant to California Elections Code Section 13308, any candidate for elective office may prepare a statement of his/her personal background and qualifications which shall be sent to each voter in a voter information pamphlet; and

WHEREAS, Section 13307 of the Elections Code of the State of California establishes certain regulations pertaining to the preparation and form of candidate statements and authorizes the City to establish certain other regulations pertaining to materials prepared by any candidate for a municipal Election, including costs of the candidates' statement; and

WHEREAS, the City is authorized to establish the maximum length of candidate statements and require each candidate filing a statement to pay in advance his or her pro rata share of the printing, handling, translating and mailing costs of including the candidate's statement in the voter pamphlet; and

WHEREAS, pursuant to the federal Voting Rights Act, all political subdivisions within the County of Los Angeles, California are required to provide translations of voting materials if more than five percent of the citizens of voting age are members of a single language minority and are limited-English proficient, which minority languages include Spanish, Vietnamese, Chinese, Japanese, Korean, Tagalog/Filipino, Thai, Hindi and Khmer/Cambodian.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. <u>General Provisions</u>. That pursuant to Section 13307 of the Elections Code of the State of California, each candidate for elective office to be voted for at an Election to be held in the City of Lawndale on November 3, 2020 may prepare a candidate's statement on an appropriate form provided by the Election Official. The statement may include the name, age and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate himself or herself. The statement shall not include party affiliation of the candidate, nor membership or activity in partisan political organizations. The statement shall be filed in typewritten form in the office of the City Clerk at the time the candidate's nomination papers are filed. The statement may be withdrawn, but not changed, during the period for filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination period.

SECTION 2. Foreign Language Policy.

- A. Pursuant to the Federal Voting Rights Act, the County is required to translate candidates' statements into the 12 qualified languages. The multilingual targeted languages for the City are: Spanish, Korean and Vietnamese.
- B. Pursuant to state law, the County will:

1. Have all candidates' statements translated into Spanish, Vietnamese, and Korean; and

2. Have additional translations prepared as requested by the candidate pursuant to Section 2(B) above; and

3. Cause the voter information pamphlet, including all candidates' statements, to be printed in English and Spanish; and

4. Cause additional translations requested and paid for by the candidate to be printed in the voter information pamphlet; and

5. Have all translations prepared by professionally certified translators meeting the requirements in California Elections Code Section 13307; and

C. The County will:

1. Mail separate Voter Information Guide including sample ballots and translated candidates statements in Korean and Vietnamese to only those voters who are on the county voter file as having requested a sample ballot in a particular language.

2. Make the Voter Information Guide, including sample ballots and candidates statements, in the City's required languages available on the County's website and at all polling places, on the County's website, and in the Election Official's office

SECTION 3. Payment.

- A. Translations: The candidate shall be required to pay for the cost of all translations of the candidate's statement.
- B. Printing: The candidate shall be required to pay for the cost of printing the candidate's statement in the main voter pamphlet.
- C. The City's Election Official shall estimate the total cost of printing, handling, translating, and mailing the candidates' statements filed pursuant to this section, including costs incurred as a result of complying with the Voting Rights Act of 1965 (as amended), and require each candidate filing a statement to pay in advance to the City his or her estimated pro rata share as a condition of having his or her statement included in the voter's pamphlet. The estimate is just an approximation of the actual cost that varies from one Election to another Election and may be significantly more or less than the estimate, depending on the actual number of candidates filing statements. Accordingly, the Election Official is not bound by the estimate and will, on a pro rata basis, bill the candidate for additional actual expense or refund any excess paid depending on the final, actual cost. In the event of underpayment, the clerk may require the candidate to pay the balance of the cost incurred. In the event of overpayment, the clerk shall prorate the excess amount among the candidates and refund the excess amount paid within 30 days of the Election.

## SECTION 4. The Voter Information Pamphlet, Additional Regulations.

A. The Election Official shall ensure that all candidates' statements printed in the voter information pamphlet are printed in type of uniform size and darkness, and with uniform spacing, and specifically shall not allow bold type, underlining and capitalization of full words. In addition, no statement shall not include any emphasis in

the body of the text including, but not limited to, numbered lists, asterisks, bullets, any leading hyphens, etc.

- B. The Election Official shall comply with all recommendations and standards set forth by the California Secretary of State regarding candidate occupational designations and other matters relating to Elections.
- C. No candidate will be permitted to include additional materials in the voter information pamphlet.

SECTION 5. The Elections Official shall provide each candidate or the candidate's representative with a copy of this resolution at the time nominating petitions are issued.

SUBJECT:	Update on the Use of the Best Western Hotel and the Baymont Inn as Temporary Homeless Shelters Through Project Roomkey

#### BACKGROUND

On April 3<sup>rd</sup>, in an effort to provide shelter to asymptomatic homeless individuals who are most susceptible to COVID-19 (those 65 years of age or older or have a pre-existing medical condition), Governor Gavin Newsom launched "Project Roomkey" which aims to provide hotel and motel rooms for the state's unhoused population. The Best Western Plus South Bay Hotel, located at 15000 Hawthorne Boulevard was contacted by, and accepted an offer from the County, independent of and without consulting the City to secure the use of the entire hotel for a three month period, with the possibility of extending the duration of the contract for an additional three, one month periods.

On April 15<sup>th</sup>, members of the Los Angeles Homeless Services Authority (LAHSA) and People Assisting the Homeless (PATH), began operating the Best Western as a Project Roomkey hotel. The hotel began admitting homeless guests on April 23<sup>rd</sup>, with the objective of filling all 97 available rooms.

On May 27<sup>th</sup>, a second Project Roomkey hotel opened in Lawndale. The Baymont Inn located at 14814 Hawthorne Blvd has 106 rooms and will be utilizing 103 rooms to house homeless individuals for the duration of this pandemic. Day to day operations at this property are conducted by First to Serve, a faith based homeless care provider.

This report is intended as an update of both Project Roomkey's operations in Lawndale.

#### STAFF REVIEW

Since opening its doors to homeless guests, the Best Western has maintained a near full capacity with currently 94 rooms occupied and 106 occupants. The hotel continues to be staffed by two medical personnel each day from 7:00 am until 7:00 pm who check the temperature and make health assessments of everyone entering the hotel. The hotel also has two security guards assigned to the property 24 hours a day who do regular patrols of the property, and monitor all traffic into and out of the property. Also, the east entrance to the parking lot has been and will remain secured for the duration of Project Roomkey, to prevent hotel guests from gaining direct access into the neighborhood east of the hotel.

LAHSA and PATH also have staff on site to provide Case Management services to all homeless guests, with the ultimate goal of finding them long term housing.

The Director of Municipal Services for the City of Lawndale has been assigned to act as a liaison with all hotel, PATH, and LAHSA staff for the duration of this project, on all things relative to Project Roomkey. The Director of Municipal Services currently visits the hotel and makes contact with hotel staff on a twice daily basis.

To date, there have been no significant incidents of criminal behavior or suspicious activity which would be cause for alarm, and staff has observed a noticeable reduction in the number of homeless on City streets. Staff provided PATH with a list of known homeless Lawndale residents who met the criteria for admission into the hotel. PATH has provided the City with 24 rooms for Lawndale homeless and all 24 of those promised rooms are being used for homeless individuals from Lawndale. The Municipal Services Department, as part of the City of Lawndale Homeless Outreach Program had made contact with some of Lawndale's homeless residents prior to the start of Project Roomkey, using phone numbers obtained through the Outreach program were able to contact and confirm with them directly that they had been given rooms at the hotel.

The Baymont Inn is operating at similar levels as the Best Western with 90 of its total 103 rooms available for Project Roomkey occupants, and currently houses 99 homeless guests. Security and First to Serve staff will be on site 24 hours a day for the duration of this operation, and medical staff will be on hand and case managers will also be active participants in the day to day operations at the hotel. Staff will continue to make twice daily visits to this property as well as the Best Western to remain informed and aware of any safety or policy concerns.

City of Lawndale staff informed hotel management that the City expects the hotel to collect and pay transient occupancy tax (TOT) as their rooms are rented and in use.

Staff will continue to provide the City Council with Project Roomkey updates at all City Council meetings for the duration of Project Roomkey.

#### FISCAL IMPACT

Estimated annual funding requirements are unknown at this time, although staff and Sheriff's deputies are monitoring the hotel, resulting in a reduction in time available for other duties.

#### **RECOMMENDATION**

Staff recommends that the City Council receive and file this report, and provide direction to staff as appropriate.

SUBJECT:	Considerations of Further Modifications to City Recreation Programming Due to COVID-19 Pandemic

#### BACKGROUND

Due to the COVID-19 (Coronavirus) pandemic and ongoing "Safer at Home" and "Shelter in Place" orders as directed by federal, state and county officials, the City made formal operational modifications on March 16<sup>th</sup>, April 6<sup>th</sup>, May 18<sup>th</sup> and June 1<sup>st</sup>.

#### STAFF REVIEW

#### **Previous Program Cancellations:**

On March 16, 2020, the City Council moved to cancel the following special events to discourage group gatherings and stop potential spread of COVID-19: 1) Youth in Government Day; 2) Clean-up Week; 3) City-wide Clean-up Day; and 4) Easter Egg Hunt. In addition, the following senior and other recreation activities were suspended: 1) Senior Congregate Meals Program (On-site program only); 2) Senior Fitness Programs; 3) All other Recreation Classes; and 4) All programming at City parks and joint-use facilities.

On April 6, 2020, the City Council cancelled the following special event programs: 1) Lawndale Community Bike Ride; and 2) Lawndale Youth Day Parade.

On May 18, 2020, the City Council cancelled the public version of the Memorial Day Ceremony in favor of a virtual Memorial Day Ceremony. In addition, the City Council cancelled the Health, Safety and Pet Fair scheduled for Saturday, June 6, 2020.

On June 1, 2020, the City Council cancelled the annual Summer Youth Basketball and Summer Day Camp programs in addition to upholding the suspension of "All other Recreation Classes" previously suspended on March 16, 2020 through the end of the summer programming session.

#### Inaugural Lawndale Music Festival:

In January, the Inaugural Lawndale Music Festival date was set for Saturday, July 18, 2020, by the funding body, the Parks, Recreation and Social Services Commission (PRSSC).

In March, when City staff began recruiting bands to play at the event, the COVID-19 pandemic had just began to take hold and it was unclear how severe the pandemic would get. However, knowing that the pandemic could get worse, City staff discussed Sunday, September 13, 2020, as a potential alternate date with each band leader. Subsequently, three of the four band leaders confirmed that they are available to perform on this date if necessary.

#### Postponement of the Inaugural Lawndale Music Festival:

Due to the current COVID-19 pandemic, it remains to be seen how the "Safer at Home" and "Shelter in Place" orders will be revised in the coming weeks. However, per Los Angeles County Department of Public Health in its Revised Order of June 11, 2020, "the Health Officer orders the continued closure of higher-risk activities where more frequent and prolonged person-to-person contacts are likely to occur." Also, the modified order specifically references "festivals" as prohibited.

In addition, City staff feels as though it would be a gamble having this event as originally scheduled as such event may likely result in disappointing levels of spectator involvement. Furthermore, City staff has not initiated any advertising for the event due to concern with spending money on an event that may not occur.

As such, staff recommends postponing the Inaugural Lawndale Music Festival to September 13, 2020. If approved by the City Council, the City could host a two-day music festival comprised of the 8<sup>th</sup> Annual Lawndale Blues Festival on Saturday, September 12, 2020, followed by the Inaugural Lawndale Music Festival on Sunday, September 13, 2020 at Jane Addams Park.

#### COMMISSION REVIEW

The PRSSC was made aware of City staff's intention to recommend the postponement of the event at its June 8, 2020, regularly scheduled Webex virtual meeting. As a result, none of the PRSSC members present had any comments regarding this topic.

#### FISCAL IMPACT

The Inaugural Lawndale Blues Festival will be funded by PRSSC Fireworks Trust Fund account made up of revenues collected from previous fireworks stand fundraising efforts.

#### RECOMMENDATION
