RESOLUTION NO. 2452-84

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY ON APRIL 10, 1984, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY THE PROVISIONS OF LAW.

WHEREAS, a general municipal election was held and conducted in the City of Lawndale, California, on Tuesday, April 10, 1984, as required by law; and

WHEREAS, notice of the election was duly and regularly given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Ccde of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution No. 2413-84 adopted December 19, 1984, the City Clerk of the City canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNDALE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1:

That the whole number of votes cast in the City except absent voter ballots was 1821.

That the whole number of absent voter ballots cast in the City was 61, making a total of 1882 votes cast in the City.

Section 3:

That the number of votes given at each precinct and the number of votes given in the City to each of such persons above named for the respective offices for which the persons were candidates (and for and against the measure) were as listed in Exhibit "A" attached.

Section 4:

The City Council does declare and determine that:

Sarann Kruse was elected as Mayor of the City for the full term of two years;

Terry W. Birdsall was elected as Member of the City Council for the full term of four years;

Dan McKenzie was elected as Member of the City Council for the full term of four years;

Harold E. Hofmann was elected as Member of the City Council for a term of two years as provided for in Resolution 2287-82, passed September 7, 1982.

That as a result of the election, a majority of the qualified voters voting on the measure relating to did vote in favor of it, and that the proposition was carried, and shall be deemed adopted and ratified.

Section 5:

The City Clerk shall enter on the records of the city Council of the City, a statement of the result of the election, showing:

- The whole number of votes cast in the City; (1)
- The names of the persons voted for; (2)
- The Measure voted upon: (3)
- For what office each person was voted for; (4)
- The number of votes given at each percinct to each person, (5) and for and against each measure;
- The number of votes given in the city to each person, and for and against each measure.

Section 6:

That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each person elected, the Oath of Office perscribed in the State. Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7:

That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
