**A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF LAWNSDALE, CALIFORNIA,
RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION
HELD ON NOVEMBER 7, 2000, DECLARING THE RESULT AND
SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a Special Municipal Election was held and conducted in the City of Lawnsdale, California, on Tuesday, November 7, 2000, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. CC-0005-46, adopted May 15, 2000, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNSDALE, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots and provisional ballots was 5,499.

That the whole number of absent voter ballots cast in the City was 1,043, making a total of 6,542 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for City Clerk are as follows:

Uffe Moller

That Measure L voted upon at the election is as follows:

Shall Ordinance No. 878-00 be adopted increasing the expenditure limit for certain public facility developments as specified in Municipal Code Chapter 2.72?

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates, and for and against the measure were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that:

Paula Hartwill was elected as City Clerk for the remaining term of office in which a vacancy has existed, which term of office ends April 23, 2002



That the Acting City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the Acting City Clerk and authenticated; that the Acting City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.



SUBJECT: November 2000 Special Municipal Election - Certification of Results

BACKGROUND

On February 7, 2000, the City Council declared the office of City Clerk to be vacant and called for a special municipal election to be held on November 6, 2000 to fill the vacancy. On July 10, the City Council ordered that a measure be submitted to the voters which, if passed, would amend municipal code chapter 2.72 and increase the expenditure limit authorized therein. The Los Angeles County Board of Supervisors was requested to consolidate the special municipal election with the statewide general election scheduled for November 7, 2000.

STAFF REVIEW

Following the election, and pursuant to Resolution No. CC-0005-46, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election. On Friday, December 1, 2000, Registrar-Recorder/County Clerk Conny B. McCormack certified the results of the election as follows:

- Of the two candidates for the office of City Clerk, Paula Hartwill and Uffe Moller, Paula Hartwill was elected for a term to end on April 23, 2002.
- Measure L, which asked "Shall Ordinance No. 878-00 be adopted increasing the expenditure limit for certain public facility developments as specified in Municipal Code Chapter 2.72?", was not approved and is, therefore, not adopted and ratified.

Now that the county elections official has canvassed the election and forwarded an official statement of results, the City Council must now declare the results of the election. Resolution No. CC-0012-129 has been prepared for this purpose.
