BACKGROUND

On February 7, 2000, the City Council declared the office of City Clerk to be vacant and called for a special municipal election to be held on November 6, 2000 to fill the vacancy. On July 10, the City Council ordered that a measure be submitted to the voters which, if passed, would amend municipal code chapter 2.72 and increase the expenditure limit authorized therein. The Los Angeles County Board of Supervisors was requested to consolidate the special municipal election with the statewide general election scheduled for November 7, 2000.

STAFF REVIEW

Following the election, and pursuant to Resolution No. CC-0005-46, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election. On Friday, December 1, 2000, Registrar-Recorder/County Clerk Conny B. McCormack certified the results of the election as follows:

- Of the two candidates for the office of City Clerk, Paula Hartwill and Uffe Moller, Paula Hartwill was elected for a term to end on April 23, 2002.
- Measure L, which asked "Shall Ordinance No. 878-00 be adopted increasing the expenditure limit for certain public facility developments as specified in Municipal Code Chapter 2.72?", was not approved and is, therefore, not adopted and ratified.

Now that the county elections official has canvassed the election and forwarded an official statement of results, the City Council must now declare the results of the election. Resolution No. CC-0012-129 has been prepared for this purpose.
