

RESOLUTION NO. CC-0604-027

**A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF LAWNSDALE CALIFORNIA,
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION
HELD ON APRIL 11, 2006, DECLARING THE RESULTS
AND ANNOUNCING SUCH OTHER MATTERS AS REQUIRED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Lawnsdale, California, on Tuesday, April 11, 2006, as required by law; and

WHEREAS, notice of the election was given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and, in all respects, the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the City's Elections Official canvassed the returns of the election and has certified the results to this City Council, and the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAWNSDALE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots and provisional ballots was 413; that the whole number of absent voter ballots cast in the City was 381, and that the whole number of provisional ballots cast in the City was 18, for a total of 812 ballots cast in the City.

SECTION 2.

- (a) That the name of person voted for at the election for Mayor is as follows:

Harold E. Hofmann

- (b) That the names of persons voted for at the election for Member of the City Council are as follows:

Larry Rudolph
James R. Ramsey
Fred Siegel

- (c) That the names of the persons voted for at the election for City Clerk are as follows:

Paula Hartwill
Pat Kearney

SECTION 3. That the number of votes given at each precinct to each person and the number of votes given in the City to each person for the respective offices are listed on Exhibit "A", attached.

SECTION 4. The City Council does declare and determine that:


- (a) Harold E. Hofmann was elected as Mayor for the full term of two years;
- (b) Larry Rudolph was elected as Member of the City Council for the full term of four years;
- (c) James R. Ramsey was elected as Member of the City Council for the full term of four years; and
- (d) Paula Hartwill was elected as City Clerk for the full term of four years.

SECTION 5. The City Clerk shall enter into the records of the City Council of the City a statement of the result of the election showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person, and (5) The total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.



SUBJECT: General Municipal Election 2006 - Declaration of Results

BACKGROUND

The City of Lawndale conducted its general election on Tuesday, April 11, 2006, for the purpose of electing a mayor, two members of the city council and a city clerk. Pursuant to California Elections Code Sections 10262 and 10263, the elections official shall conduct the canvass of returns and certify the results of the election, and the City Council shall declare the results of the election no later than the fourth Friday after the election.

STAFF REVIEW

The canvass of the results revealed that Mayor Harold E. Hofmann, who was unopposed in this election, was elected for a two-year term. There were two candidates for the City Council, incumbents Larry Rudolph and James D. Ramsey, and one write-in candidate, Fred Siegel. James D. Ramsey and Larry Rudolph were elected, each for a four year term. There were two candidates for the office of City Clerk, Paula Hartwill and Pat Kearney, and Paula Hartwill was elected for a four-year term.

A Certificate of Canvass details the results of the election and is presented to the City Council. As required by law, the certificate includes the number of ballots cast in the election, the candidates voted for, the office each person was voted for, and the number of votes given at each precinct to each candidate. Resolution No. CC-0604-027 officially declares the results of the election and incorporates the above referenced certificate.
