Those not muting there device at the three-minute (3:00) mark will be given a reasonable amount of time to complete their public comments. Those not completing their public comment period within a reasonable amount of time will be muted by staff.

MINUTES CITY OF LAWNDALE PARKS, RECREATION AND SOCIAL SERVICES COMMISSION REGULAR MEETING – JUNE 8th, 2020

A. CALL TO ORDER AND ROLL CALL

Chairperson Harbison called the meeting to order at 7:04 p.m. in the City Hall Council Chamber, located at 14717 Burin Avenue, Lawndale, California.

B. FLAG SALUTE

C. <u>APPROVAL OF JUNE 8th, 2020 MINUTES</u>

Commissioner Rudolph made a motion, seconded by Commissioner Sitka, to approve the minutes of June 8th, 2020 as written.

F. ITEMS FROM COMMUNITY SERVICES STAFF

1. Inuagural Lawndale Music Festival:

Director Estes reported to the PRSSC that there will be an agenda item for the June 15th City Council meeting at which staff will recommend the postponement of the Inaugural Lawndale Music Festival scheduled for Saturday, July 18th, 2020. In addition, staff will recommend that the event is rescheduled to Sunday, September 13th, 2020 to follow the 8th Annual Lawndale Blues Festival.

2. Modifications to City Operations Due to COVID-19 Pandemic:

Director Estes reported to the PRSSC that in March when bands were being recruited to play at the event that it was possible that this pandemic could get worse. Therefore, staff asked each band leader if they were available to play on Sunday, September 13th, 2020, the day after the 8th Annual Lawndale Blues Festival and make it a two-day festival. At the time, three of the four bands confirmed they were available to perform on that date, if necessary.

3. FY 2020-21 General Fund Budget:

Director Estes informed the PRSSC that the Fiscal Year 2020-21 Budget was discussed in detail at the June 1st, 2020 City Council meeting. This year, the City had a five-person budget sub-committee, which included two City Councilmembers, that gathered for a number of meetings at which the City's revenue and prior year's spending habits were reviewed. The sub-committee was instrumental in making budget recommendations to the full City Council. On Wednesday, June 3rd, 2020, after some lengthy discussions, the City Council approved a balanced FY 2020-21 General Fund Budget at a special meeting held via Cisco Webex teleconferencing platform.

4. Potential Expenditure, Lawndale Care Package Program:

Director Estes gave the PRSSC a brief history of the Lawndale Care Package Program which is a community program that was developed in March with the goal of providing care packages to those in the community in need of food and other essential items. In April, the City, partnering with Restoration Life Church and Pastor Eddie Vargas, began soliciting donations for the program and ended up collecting approximately \$7,600.00 to be used to purchase food and essential items for the program. In addition to the donation money collected, Restoration Life Church was able to secure additional donations from a number of their donors. On May 8th, the City and Restoration Life Church distributed care packages to 281 families in need. Each care package included two healthy bags of food and essential items valued at approximately \$45.00 each. In total, 562 bags of perishable, non-perishable and essential items were distributed on a drive up, pickup and go basis.

After introducing the program to the PRSSC, Director Estes asked the PRSSC if they would be interested in donating to the program for a second event scheduled to take place on Friday, June 26th. Director Estes further explained that this second distribution event will be focused on Lawndale seniors first and foremost which includes a list of approximately 150 seniors in Lawndale in which care packages will be delivered to their homes on June 26th. Any number of care packages above 150 will be distributed at the church on a drive up pick up and go basis. The City and the church are putting together a minimum of 200 care packages for the June 26th Lawndale Care Package Program.

After some discussion, the PRSSC expressed a desire to donate \$5,000.00 from the PRSSC Fireworks Trust Fund account to the Lawndale Care Package Program.

Director Estes informed the PRSSC that he would provide a purchasing resolution at the June 22nd, 2020, regularly scheduled teleconference call meeting for potential approval by the PRSSC on June 22nd.

BACKGROUND

The Parks, Recreation and Social Services Commission (PRSSC) annually contributes sales revenues from its fireworks booth fund-raising efforts to the Fireworks Trust Fund account. The account was established in 2005 as a vehicle to assist the Parks and Recreation Department to make purchases when funds were limited. The purchasing policy, Section 3.10.020 of the Lawndale Municipal Code, creates a framework to authorize the PRSSC to procure supplies, services and equipment (i) related to social services and events, and (ii) for items not included in the City Budget, with the concurrence of a majority of the entire Commission.

STAFF REVIEW

In late March, the City, in partnership with Restoration Life Church and Pastor Eddie Vargas, started planning for a community outreach program involving the distribution of care packages to those in the community in need. The program, titled "Lawndale Care Package Program" held its first distribution event on Friday, May 8th, 2020, at Restoration Life Church in Lawndale.

Prior to the May 8th distribution event, the City collected approximately \$7,600.00 from various individuals and businesses in and outside of the Lawndale community which was used to purchase non-perishable and essential items for the May 8th distribution event. At this event, 281 families were provided care packages, on a drive up basis, consisting of two bags of non-perishable and essential items with an approximate value of \$45.00 per bag for a total of 562 bags.

In May, the City and the church determined that there was a desire to do a second Lawndale Care Package event to take place on Friday, June 26th at Restoration Life Church in Lawndale. As well, in May, the City began soliciting donations for the June 26th Lawndale Care Package distribution date, or round two as some have called it.

At its June 8th regularly scheduled meeting, the PRSSC considered making a donation to the Lawndale Care Package Program per a request from Mayor Robert Pullen-Miles and the City's Community Services Department. After staff gave the PRSSC a summary of the program and following some discussion, the PRSSC determined that it would like to donate \$5,000.00 to the Lawndale Care Package Program in preparation for the Friday, June 26th, 2020, care package distribution date.

Following the discussions and commitment by the PRSSC to donate \$5,000.00, Director of Community Services, Mike Estes informed the PRSSC that he would return to the June 22nd regularly scheduled meeting with a purchasing resolution for potential approval by the PRSSC.

FUNDING

Funds are available in the PRSSC Fireworks Trust Fund account to fund this particular donation.

RECOMMENDATION

STAFF RECOMMENDS that the PRSSC: 1) present a motion to approve PRSSC Resolution 1084-20, or refrain from presenting a motion in which case the item will die; and 2) second the motion, or let the motion die due to lack of a second in which case the resolution will be null and void.

Upon a positive majority vote of the PRSSC members present, staff will exercise PRSSC Resolution 1084-20 and transfer funds in the amount of \$5,000.00 from the PRSSC Fireworks Trust Fund account to the City's applicable "Community Outreach" donation account.

If, however, the item fails to obtain a majority vote of the PRSSC members present, the purchasing resolution will be null and void.



RESOLUTION NO. 1084-20

A RESOLUTION OF THE PARKS, RECREATION AND SOCIAL SERVICES COMMISSION OF THE CITY OF LAWNDALE, CALIFORNIA APPROVING THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF ESSENTIAL FOOD ITEMS FOR THE LAWNDALE CARE PACKAGE PROGRAM BENEFITING LAWNDALE SENIORS, UNDERPRIVLEGED FAMILIES AND INDIVIDUALS

WHEREAS, Lawndale Municipal Code ("LMC") Chapter 3.10 establishes the procurement policies pursuant to which the City's Parks, Recreation and Social Services Commission ("PRSSC") may spend the funds raised by the PRSSC's fireworks booth operations; and

WHEREAS, LMC Section 3.10.020 authorizes the PRSSC to procure supplies, services and equipment with funds raised by the PRSSC if a majority of the PRSSC approves the expenditure after considering the purchase as a properly agendized item at a regular public meeting of the PRSSC; and

WHEREAS, on June 22nd, 2020, at a virtual regular meeting of the PRSSC, the PRSSC considered whether to donate a portion of the funds raised by the PRSSC to the Lawndale Care Package Program for the purchase essential perishable and non-perishable food items benefitting Lawndale Seniors and other underprivileged families and individuals in the Lawndale Community.

NOW, THEREFORE, THE PARKS, RECREATION AND SOCIAL SERVICES COMMISSION OF THE CITY OF LAWNDALE, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the foregoing recitals are true and correct and incorporated herein.

SECTION 2. That the PRSSC has reviewed account statements demonstrating that PRSSC Fireworks Trust Fund Account includes sufficient funds to make the purchases being considered.

SECTION 3. That the PRSSC hereby approves the expenditure of the not to exceed amount of \$5,000.00 of the funds raised by the PRSSC fireworks sales stand to the Lawndale Care Package Program for the purchase of essential perishable and non-perishable food items benefitting Lawndale Seniors and other underprivileged families and individuals in the Lawndale Community.

SECTION 4. That the PRSSC's staff liaison is hereby directed to undertake such actions as may be necessary to donate the funds contemplated herein on behalf of the PRSSC.
