## 1. <u>Recreation Facility Security Camera Replacement Project Update</u>

Director Estes provided the PRSSC with the following project details: 1) Hogan Park has been fully completed; 2) Hopper and Rudolph Parks have been mostly completed; however, there are a few cabling issues that need to be resolved; 3) work on the Community Center has begun; 4) the City is optimistic that the project will be completed before the September 4<sup>th</sup> Labor Day holiday; 5) most cameras that have been installed are already recording; and 6) the screens and images are very clear and are able to zoom in and capture images that are very detailed.

### 2. State Grant for Lawndale Youth Development Center

Director Estes reported that the contract for the California State Grant has been approved and will be presented to the City Council at the Monday, August 21, 2023, City Council Meeting. Director Estes projected a completion date for the Lawndale Youth Development Center to be in late 2026 or early 2027.

### 3. Back to School Community Health and Resource Fair

Director Estes reported to the PRSSC that the Back to School Community Health and Resource Fair on Saturday, August 26, 2023 will be a great community event taking place from 10:00 am to 2:00 pm. The event organizers are expecting large crowds.

### 4. Lawndale Beat Fixed-route Transit Ridership Report for July

Director Estes provided the ridership report for the Lawndale Beat Fixed-route Transportation Service for July 2023. Ridership decreased by 6%, there was a total of 872 passengers. Installation of mobile validators, to charge Metro Tap Cards, is in process. An increase of ridership is expected once school resumes.

### 5. Lawndale Special Transit Vehicle Purchase

Director Estes provided a brief description of the transportation services provided for essential appointments. Director Estes reported the transit vehicle is non-operative due to a transmission mechanical issue and the City has purchased two new buses to be delivered in September 2023. Director Estes commented that the part-time transit driver position will be filled as soon as possible allowing the City to expand the Special Transit Program for seniors.
