1. Lawndale Beat Ridership Report for January

Director Estes provided the ridership report for the Lawndale Beat Fixed-route Transportation Service for January 2024. Ridership has increased and there was a total of 1,046 passengers. Installation of mobile validators, to charge Metro Tap Cards, is fully engaged. Director Estes indicated that the residential route exceeded the express route.

responded. Director Estes indicated the Request for Proposal review committee went over the proposals by cost, project list, and timeline and the committee have selected BOA Architecture.
